**ORDINANCE ESTABLISHING THE PASIG CITY BATANG CONSTABLE, DEFINING ITS DUTIES AND FUNCTIONS, APPROPRIATING FUNDS THEREFORE AND FOR OTHER PURPOSES.**

**WHEREAS**, the State recognizes the vital role of the youth in nation building including the promotion of physical, moral, spiritual, intellectual and social wellbeing of the youth to the end that the youth realize their potential for improving the quality of life;

**WHEREAS**, the National Government acknowledges the important role of the youth and has encouraged programs geared towards their total development specifically the disadvantaged youth in terms of physical, emotional, psychological, financial and social development;

**WHEREAS**, the City Government of Pasig seeks to foster volunteerism, active participation, practical skills training and promote the attributes of dependability, self-reliance, socially responsible and economically productive Pasigueño youth;

**WHEREAS**, the City Government of Pasig wants to address rising crime incidents inside and outside school premises perpetrated of youth offenders;

**WHEREAS**, the City Government values citizens participation in crime prevention programs and involving them in the planning and decision-making process specifically against criminality, consequently, the youth may be encouraged to take part in this process to help out and prevent the incidence of crimes particularly those involving the youth;

**WHEREAS**, the City Government believes that the youth could actively help keep the city peaceful, not just by avoiding being offenders or victims themselves, but by giving security to their community, assisting government employees tasked to enforce discipline, encouraging youth participation and building self-esteem by instilling discipline and molding the characters of the new generation;

**NOW THEREFORE BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG IN SESSION DULY ASSEMBLED THAT:**

**SECTION 1.** This Ordinance shall be known as the Pasig City Batang Constable.

**SECTION 2. Purpose** – The Pasig City Batang Constable shall:

2.1 Provide opportunities to young Pasigueños, particularly the out-of-school youth and Alternative Learning System (ALS) members to actively participate in the various advocacies of the city's concern for public safety and security.

2.2 Intensify youth participation in the campaign for public safety and security and other programs of the city government while developing their capabilities to become leaders and good example;

2.3 Provide opportunities to gain experience, mold character, instill discipline and earn income to enable them to sustain, continue and pursue their schooling;

**SECTION 3. FUNCTIONS** – The Pasig City Batang Constable shall serve as auxiliary support group tasked to assist the City Ordinance Police (COP) under the Batas ng Ciudad Enforcement Office, school authorities and other law enforcement groups under the city in the maintenance, advocacy and promotion of public safety and security.

**SECTION 4. DUTIES AND RESPONSIBILITIES** – The Pasig City Batang Constable shall in coordination with the Local Youth Development Office (LYDO), school authorities and Batas ng Ciudad Enforcement Office (BCEO);

4.1 Formulation and adaptation of policies and guidelines in the implementation of the Pasig City Batang Constable;

4.2 Assist in preparation and drafting of the Implementing Rules and Regulations/Guidelines of this Ordinance;

4.3 Assist in recruitment of members of the Batang Constable;

4.4 Coordinate with the Local Youth and Development Office (LYDO) and the Batas ng Ciudad Enforcement Office (BCEO) in relation to the operations of the Batang Constable;

4.5 Submit regularly an accomplishment report to the Honorable City Mayor and annually to the City Planning and Development Office;

4.6 Exercise such other powers and functions implied, inherent or necessary to the efficient and effective implementation of the programs.

4.7 Will undergo regular training compulsory (civilian military training)

**SECTION 5. QUALIFICATIONS OF MEMBERS OF THE PASIG CITY BATANG CONSTABLE** – The following shall be eligible to be members of the Batang Constable:

- 5.1 Filipino citizen
- 5.2 18-22 years old
- 5.3 Registered voter of Pasig
- 5.4 Resident of Pasig for at least five (5) years
- 5.5 At least a high school graduate and/or a student of Alternative Learning System (ALS)
- 5.6 Must have not been convicted of any administrative or criminal offense
- 5.7 Must have undergone drug test administered by an accredited drug testing agency
- 5.8 Must not be a member of any street gang

**SECTION 6. COVERAGE** – Members of the Pasig City Batang Constable will serve for a period of one (1) year, renewable at the discretion of the City Mayor and shall report at least four (4) hours daily.

Members of the Batang Constable shall be entitled to receive an allowance of Five Thousand Pesos (P5,000.00) per month.

**SECTION 7. APPROPRIATION** – There is hereby appropriated the amount of Ten Million Pesos (P10,000,000.00) to cover payment of allowances of members of the Batang Constable, training expenses, clothing/uniforms and other expenses necessary subject to budgetary limitations provided under the Local Government Code and pertinent Accounting rules and regulations.

**SECTION 8. SEPARABILITY CLAUSE** - In the event that a provision of this Ordinance is found or decreed to be invalid or unconstitutional, all other provisions hereof not affected by such pronouncement or decree shall remain to be in full force and effect.


**SECTION 10. EFFECTIVITY** – This Ordinance shall take effect immediately upon approval.
