WHEREAS, it is hereby declared the policy of the state "to adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. xxx";

WHEREAS, the City Government of Pasig aims to expand its health care programs by providing additional health care services in various city-owned and operated health facilities;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG IN SESSION DULY ASSEMBLED THAT:

SECTION 1. Section 5 of Ordinance No. 03, Series of 2017 is hereby amended to be read as follows:

"Section 5. – The Pasig Health Care Commission who shall serve on a co-terminous basis with the appointing authority"

SECTION 2. Section 6 of Ordinance No. 03, Series of 2017 is hereby amended to be read as follows:

"Section 6. Coverage. – Indigent, low-income residents of the City of Pasig shall be entitled to membership to the E-health Card Program, subject to review by the Commission."

Applicants shall submit the following:

- a) Certificate of Indigency/Assessment Report from the PSWD
- b) Voters ID/Certification from COMELEC
- c) Other necessary documents as may be required by the Commission

SECTION 3. Section 7 of Ordinance No. 03, Series of 2017 is hereby amended to be read as follows:

"Section 7. Entitlement to Benefits – Subject to the limitations specified by this ordinance and as may be determined by the Commission, the following shall be available to members and their qualified beneficiaries:

- a) Emergency Services (ER)
- b) Outpatient Consultation
- c) Hospitalization (in-patient services)

SECTION 4. A new Section of the City Ordinance No. 03, Series of 2017, as amended, is hereby added to read as follows:

"Section 8. E-health card member/beneficiaries may avail of the services in the following public hospitals and health care facilities managed and operated by the City Government of Pasig upon submission of endorsement from the Pasig City Social Welfare Department (PSWD):

- a) Pasig City General Hospital (PCGH)
- b) Pasig City Children's Hospital (PCCH)
- c) Center for Dialysis, health Lifestyle, Ambulatory Surgery, Maternity Clinic, and Newborn Care (CHAMP)
- d) All Super Health Centers in Pasig City

SECTION 5. The succeeding subsections are renumbered accordingly.

SECTION 6. REPEALING CLAUSE. All previous ordinances, executive orders, rules and regulations or parts thereof which are inconsistent with this ordinance are hereby repealed and modified accordingly.

SECTION 7. EFFECTIVITY - This Ordinance shall take effect immediately upon approval.




