AN ORDINANCE GIVING CASH INCENTIVES FOR LOCAL ATHLETES WHO WILL WIN IN A REGIONAL, NATIONAL AND INTERNATIONAL SPORTS COMPETITION TOGETHER WITH THEIR COACHES AND TRAINERS AND PROVIDING FUNDS FOR ITS IMPLEMENTATION.

WHEREAS, Article XIV, Section 19 (1) of the 1987 Philippine Constitution provides that, "The state shall promote physical education and encourage sports programs, league competitions and amateur sports, including training for international competitions to foster self-discipline, teamwork and excellence for the development of a healthy and alert citizenry;

WHEREAS, Republic Act No. 9064 also states that, "promoting excellence in sports and through sports by providing for the welfare of national athletes, coaches and trainers competing for the city and the country having particular benefits and incentives for those who brought honor and recognition to the beloved City of Pasig and to our country by winning in sports competitions";

WHEREAS, the above-quoted provision reiterate the importance of giving financial incentives to further motivate athletes, coaches and trainers winning in national and international competitions;

WHEREAS, regional competitions especially among schools being participated in by athletes from different schools of Pasig City are equally as important in international and national competitions to further honing the skills and encouraging top athletes to pursue higher goals in the selected events;

WHEREAS, the City Government intends to give due honor and recognition for outstanding Pasig Athletes by granting cash incentives for those who contributed significantly to the history of sports in Pasig and gathering championship trophies and medals during national and international competitions in their respective events;

WHEREAS, the important roles by the coaches for the Pasig athletes are likewise recognized through cash incentives to be given to coaches on a per event basis;

WHEREAS, the Person with Disability (PWD) are equally encouraged and recognized in their efforts to actively participate in the national and international competitions;

WHEREAS, the Coaches of the Athletes under PWD are likewise recognized in their efforts to diligently train and prepare for the national and international competitions;

AN ORDINANCE GIVING CASH INCENTIVES FOR LOCAL ATHLETES WHO WILL WIN IN A REGIONAL, NATIONAL AND INTERNATIONAL SPORTS COMPETITION INCLUDING PERSON WITH DISABILITY (PWD) TOGETHER WITH THEIR COACHES AND TRAINERS AND PROVIDING FUNDS FOR ITS IMPLEMENTATION.

WHEREAS, the City Government intends to institutionalize and integrate youth and sports development program extending to athletes of Persons With Disability by envisioning the continuity and sustainability of the "INTEGRATED YOUTH AND SPORTS ORDINANCE FOR THE CITY OF PASIG" transcending the changes in the city's administration, until it is either repealed or amended in order to give way for a better sports program for the city:

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod in session assembled that:

SECTION 1. TITLE – This Ordinance shall be known as "THE ORDINANCE IN AWARDING CASH INCENTIVES TO FILIPINO BORN ATHLETES, COACHES, AND TRAINERS OF PASIG CITY"

SECTION 2. DEFINITION OF TERMS – As used in this Ordinance, the following terms shall be as follows;

- A. Cash Incentives – this refers to the specific amount given to athletes, coaches, trainers stated in this ordinance who won in regional, national and international tournaments and competitions.
- B. "Regional Competitions" – refer to the recognized competitions authorized by the national government namely the NCR Meet; Milo Olympics; Palarong Panrehiyon of the Department of Education and such other competitions participated by all entries constituting a region.
- C. "National Competitions" – refer to the recognized competitions authorized by the national government namely Palarong Pambansa; Batang Pinoy; Philippine National Games (PNG) National Open or a sports competition participated by all regions within the country.
- D. "International Competitions" - refer to the recognized sports competitions internationally recognized namely Olympic Games, Quadrennial World Championship, Asian Games and Southeast Asian Games (SEA GAMES); Annual World Championships as recognized by sports world council.
- E. "Filipino Born Coach" – certified Pasig City residence and recognized as official coach for particular sports competition and endorsed through certification by the sports association whom they participated as an official coach representative for their respective sports discipline.

F. "FILIPINO Born Athletes" – certified by a passport fully supported by birth certificate who are certified Pasig residents in individual and team sports whether in regular competitions or under Persons With Disabilities duly endorsed by the PASIG LGU Sports Development Head.

SECTION 3. CASH BENEFITS FOR ATHLETES – The cash incentives to Athletes who are bona fide residents of Pasig, coaches and trainers qualified in the criteria enlisted in this ordinance who are identified consistent to bring honor to the City by garnering awards from national and international competitions as follows:

SECTION 4. IMPLEMENTATION – The Committee Chair on Sports shall recommend and release the appropriate cash incentives for the qualified athletes, coaches and trainers upon approval of the City Mayor and availability of funds subject to COA procedures.

SECTION 5. FUNDING FOR THE PROGRAM – Funding for the program shall come from the city development fund, sponsorship and donations from outside sources.

SECTION 6. CONTINUITY OF THE PROGRAMS – the cash incentives to Filipino athletes, together with their Filipino coaches and Filipino trainers must be strictly limited to Pasig residents.

SECTION 7. SEPARABILITY CLAUSE – if for any reason, any provision or section or part of this ordinance is declared not valid by a Court of competent jurisdiction or suspended or veto by the City Mayor, such judgment shall not affect or impair the remaining provisions, section, or parts thereof, which shall remain or continue to be in full force and effect.

SECTION 8. REPEALING CLAUSE – This Ordinance repeals Ordinance No. 14, series of 2008 and Ordinance No. 9, series of 2009 and other provisions of all ordinances or resolutions inconsistent to any of the provisions of this Ordinance are hereby repealed.

SECTION 9. EFFECTIVITY – This Ordinance shall take effect upon approval of the Sangguniang Panlungsod and subsequent review by the City Mayor.
