**WHEREAS**, in order to clarify the intension of Section 108 of Ordinance No. 23, series of 2016, there is a need to amend certain provisions of said section;

**WHEREAS**, in order to avoid different interpretations, the City Council deems it necessary to amend Section 108 of Ordinance No. 23, series 2016.

**NOW, THEREFORE, BE IT ORDAINED**, by the Sangguniang Panlungsod of Pasig in session duly assembled that:

**SECTION 1.** Section 108, letter a and b of Ordinance No. 23, series of 2016 is hereby amended to be read as follows:

(a) Any person shall, at all times, wear a standard motorcycle helmet while riding a motorcycle. That each rider and/or passenger shall securely fasten the personal safety device while the motorcycle is being operated on any road, street, avenue or highway.

(b) A standard motorcycle helmet should be in compliance with the standards set by the DTI and RA 10054 and should be worn and fastened properly while the motorcycle is being operated.

**SECTION 2.** This ordinance shall take effect upon its approval.
