**NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG, IN SESSION DULY ASSEMBLED THAT:**

**Section 1.** The amount necessary for the implementation of Executive Order No. 201, issued February 19, 2016, is hereby appropriated as compensation adjustment for the employees of the City Government of Pasig and in pursuant to the implementing guidelines of the Department of Budget and Management, funds to be taken out from the approved Executive Budget CY 2019, the Salary Savings and from other sources available in the City Treasurer.

**Section 2.** The City Treasurer and the Budget Officer are hereby directed to implement this Ordinance pursuant to the provisions of the above Executive Order and in accordance with the implementing guidelines issued by the Department of Budget and Management (DBM), subject to all legal and auditing rules and procedures.

**Section 3.** The implementation of this compensation adjustment is effective on January 1, 2019.






