WHEREAS, Section 458 (a) (1) (viii) of the Local Government Code provides that the Sangguniang Panlungsod is empowered to determine the position and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the City Government;

WHEREAS, certain positions in Local Government Units (LGUs) have been allocated via Department of Budget (DBM) National Budget Circular No. 21, Series of 2009 Local Budget Circular No. 92, Series of 2009, DBM Budget Circular No. 2, Series of 2018 and other DBM related issuances which will change one or two or all the following attributes: position title, level and salary grade;

WHEREAS, the City Government deems it proper to give recognition via providing competitive salaries to city employees who passed the licensure examinations in their respective fields including those with specialized knowledge and expertise;
