WHEREAS, a commitment to extend the best pediatric hospital service in the City of Pasig, the Pasig City Children's Hospital (PCCH) was inaugurated in 2014 with an initial 64-bed capacity;

WHEREAS, Section 76 of the Local Government Code provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission;

WHEREAS, in preparation for the expansion to 120-bed capacity of the PCCH, a proposal to abolish unnecessary and unfilled positions and the creation of new and additional positions is hereby submitted;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD, IN SESSION DULY ASSEMBLED THAT:
