**WHEREAS**, it is also believed the patron saint Sta. Teresa De Avila was adored and recognized by majority of the inhabitants of Barangay Pineda by more than one hundred years form now;

**WHEREAS**, the residents of New MRR Street in Barangay Pineda are the one requesting for the renaming of their street in honor of their Patron Saint in Barangay Pineda.

**BE IT ORDAINED BY THE PASIG CITY COUNCIL IN SESSION, ASSEMBLED THAT:**

**SECTION 1.** NEW MRR STREET in Barangay Pineda is hereby renamed as STA. TERESA DE AVILA STREET.




**SECTION 3.** A copy of this Ordinance shall be forwarded to the Philippine Historical Commission, City Library and Engineering Office.


**SECTION 4.** This ordinance shall take effect immediately upon approval.


