NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG IN SESSION DULY ASSEMBLED THAT:

SECTION 1. Section 36, Article XII of Ordinance No. 24, Series of 2016 is hereby amended to be read as follows:

ARTICLE XII
TRICYCLE/PEDICAB FARES AND PASSENGERS

"Section 36. – The maximum number of passengers shall be dependent on the size and built of the tricycle unit, but shall not exceed **seven (7) passengers including the driver**. No tricycle unit is allowed to overload and to allow passenger(s) atop the tricycle unit or in any part of the unit exposing their passenger(s) to dangers to their lives and limbs. Provided, the TORO after evaluation may recommend to the Honorable City Mayor an exception to the number of passengers. The City Administrator is authorized to increase the number of passenger to be loaded in a tricycle upon jurisdiction and recommendation of the Chief of TORO. The maximum number of passengers per tricycle unit, including the driver has to be declared in their application for franchise and duly approved after inspection of the unit by the TORO, and to be displayed inside their units.

SECTION 2. Section 56, Article XVI of Ordinance No. 24, Series of 2016 is hereby amended to be read as follows:

ARTICLE XVI
ELECTRIC TRICYCLES

"Section 56. **Duly Licensed E-Trike Driver.** – Electric Tricycle that are used for service, private, or public, must be driven or operated by a duly licensed driver. The maximum number of passengers shall be dependent on the size and built of the electric tricycle unit, but shall not exceed **eight (8) passengers including the driver**. No electric tricycle unit is allowed to overload and to allow passenger(s) atop the electric tricycle unit or in any part of the unit exposing their passenger(s) to dangers to their lives and limbs. Provided, the TORO after evaluation may recommend to the

Honorable City Mayor an exception to the number of passengers. The City Administrator is authorized to increase the number of passenger to be loaded in a tricycle upon jurisdiction and recommendation of the Chief of TORO. The maximum number of passengers per electric tricycle unit, including the driver has to be declared in their application for franchise and duly approved after inspection of the unit by the TORO, and to be displayed inside their units.

SECTION 3. REPEALING CLAUSE. All previous ordinances, executive orders, rules and regulations or parts thereof which are inconsistent with this ordinance are hereby repealed and modified accordingly.

SECTION 4. EFFECTIVITY - This Ordinance shall take effect immediately upon approval.
