AN ORDINANCE ESTABLISHING THE PASIG CITY DRUG REHABILITATION CENTER

WHEREAS, the 1987 Philippine Constitution provides that the duty of the State is to safeguard the well-being of its citizenry particularly the youth, from the harmful effects if dangerous drugs;

WHEREAS, Republic Act No. 9165, otherwise known as the Dangerous Act prescribes the guidelines for the formulation and implementation of a comprehensive anti-dangerous-drug program which includes among other things the treatment and rehabilitation of drug dependents;

WHEREAS, the current situation of drug problem in the country and the strong campaign of President Duterte against drugs led to the encouragement of local governments to establish their own drug treatment and rehabilitation centers;

WHEREAS, Pasig City is implementing various programs and intensive campaign intended to reduce the drug problem in the city and in the process has already declared half of its barangays as drug-cleared and has been declared as the leading anti-drug council in Metro Manila;

WHEREAS, despite its achievements, Pasig City continues to expand its efforts to be more self-reliant in its anti-drug campaign and has identified the area of treatment and rehabilitation needing a more serious attention;

WHEREAS, Republic Act 9165, otherwise known as "Comprehensive Dangerous Drug Act of 2002", mandates the Department of Health to regulate, oversee and monitor the integration, coordination and supervision of all drug rehabilitation, intervention, aftercare and follow up programs, projects and activities as well as the establishment, operations, maintenance and management of Drug Abuse Treatment and Rehabilitation Centers nationwide;

WHEREAS, to complement the city's efforts on the campaign against illegal drugs, and in response to the call of being self – sufficient in its own anti-drug campaign, a proposal for the establishment of a Pasig City Drug Rehabilitation Center is hereby presented;

NOW THEREFORE BE IT ORDAINED THAT:

SECTION 1. TITLE – This ordinance will be known as the "Establishment of the Pasig City Drug Rehabilitation Center (Pasig Rehab Center)"

SECTION 2. GUIDING PRINCIPLE - Substance dependence is a chronic relapsing disease brought about by a complex interplay of biopsychosocial factors. As such treatment is not focused on one target alone but is refined to the individual needs of the patients taking into consideration the variations of influences around him/her..

SECTION 3. MISSION- It is the mission of the Pasig Rehab Centerto be a model center for excellent and effective treatment and rehabilitation of drug dependents in Pasig City and neighboring cities and municipalities in providing holistic lifelong recovery.

SECTION 3. SCOPE - The Pasig Rehab Center is a residential health facility that provides comprehensive rehabilitation services utilizing among others, any of the accepted modalities: Multidisciplinary Team Approach, Therapeutic Community Approach and/or Spiritual Services towards the rehabilitation of a drug dependent.

SECTION 4: NATURE OF INSTITUTION - the Pasig Rehab Center is a freestanding health facility operated and maintained by the City Government of Pasig. It primarily serves the needs for treatment and rehabilitation of drug dependents of Pasig City but also caters to non-residents of Pasig. Within Pasig City, it forms part of a constellation of a comprehensive anti-drug program services represented by the following: Anti-Drug Council of Pasig City (ADCOP), Pasig City General Hospital Screening Drug Testing Laboratory (PCGH-SDTLab), Pasig City Confirmatory Drug Testing Laboratory at the Pasig City General Hospital (PCGH – CDTLab), Pasig City Drug Recovery Center at the Pasig City General Hospital (PCGH-DRC) and Substance Abuse Treatment Hub of Pasig City (SATOP).

SECTION 5. QUALIY OF SERVICE AND CAPABILITY - Pasig Rehab Center shall comply with the standards set by the Department of Health in their Manual of Operation for Drug Abuse Treatment and Rehabilitation Center and will work towards accreditation by the appropriate office of DOH prior to operation. Standards in personnel requirement, physical plant and equipment shall be met.

SECTION 6. APPROPRIATION - The sum of FIFTYMILLION PESOS shall be allocated for Pasig Rehab Center annually.

SECTION 7. SEPARABILITY CLAUSE - If any provision of this Ordinance is declared unconstitutional or invalid, the provisions not affected thereby shall continue to be in full force and effect.

SECTION 8. REPEALING CLAUSE -All previous ordinances and provisions inconsistent with this Ordinance shall be deemed repealed and modified accordingly.

SECTION 9. EFFECTIVITY - This Ordinance shall take effect upon its approval.

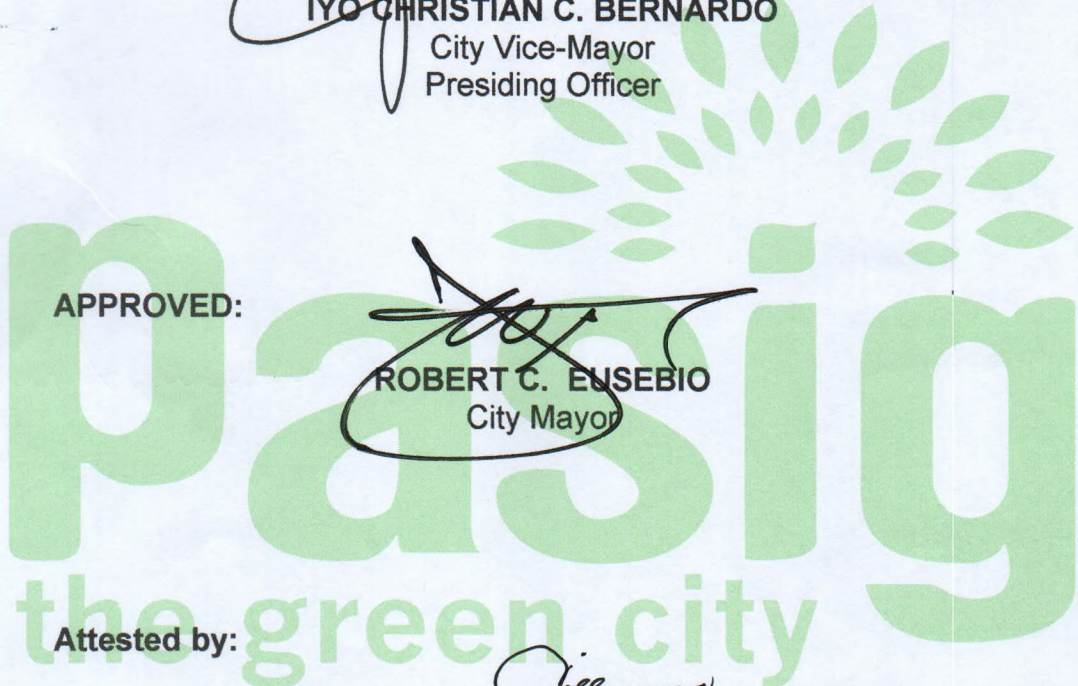
