AN ORDINANCE AMENDING ORDINANCE NO. 1 SERIES OF 2019 AND FOR OTHER PURPOSES.

WHEREAS, Section 455 (b) (1) (v) of the Local Government Code of 1991 provides that the Local Chief Executive has the power to appoint all officials and employees of the city government;

WHEREAS, Section 454 (d) of the Local Government Code of 1991 provides that the heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of all Sanggunian members;

WHEREAS, Ordinance No. 1 series of 2019 created the position of "Secretary to the City Mayor" under the Office of the City Mayor, defining its duties and functions, and appropriating the necessary funds therefor and for other purposes;

WHEREAS, upon consultation and verification of the Pasig City Human Resource Development Office with the Civil Service Commission – Field Office (CSC-FO), it was found out that the position title "Secretary to the City Mayor" is non-existent and/or non-applicable for local government units;

WHEREAS, the Pasig City Human Resource Development Office recommends that an amendment to the position title of "Secretary to the City Mayor" be changed into "City Government Department Head II" for the purpose of complying with the Department of Budget and Management (DBM) Index of Occupational Services.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF PASIG IN A REGULAR SESSION DULY ASSEMBLED:

SECTION 1. AMENDMENT TO THE POSITION TITLE "SECRETARY TO THE CITY MAYOR" – The position title "Secretary to the City Mayor" as used in Ordinance No. 1 series of 2019 is hereby amended as "City Government Department Head II" whose rank and benefits shall be that of the Department Head of the City.

SECTION 2. REPEALING CLAUSE – Any ordinance, resolution, and executive order inconsistent with this ordinance is hereby repealed.

SECTION 3. EFFECTIVITY – This ordinance shall take effect immediately.
