**AN ORDINANCE AMENDING ORDINANCE NO. 2 SERIES OF 2019 AND FOR OTHER PURPOSES.**

**WHEREAS**, Section 455 (b) (1) (v) of the Local Government Code of 1991 provides that the Local Chief Executive has the power to appoint all officials and employees of the city government;

**WHEREAS**, Section 454 (d) of the Local Government Code of 1991 provides that the heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of all Sanggunian members;

**WHEREAS**, Ordinance No. 1 series of 2019 created the position of "Action Officer" to head the Local City Disaster Risk Reduction and Management Office, defining its duties and functions, and appropriating the necessary funds therefor and for other purposes;

**WHEREAS**, pursuant to Joint Circular No. 2014 – 1 of the National Disaster Risk Reduction and Management Council, Department of Interior and Local Government, Department of Budget and Management, and Civil Service Commission, under Section 5.6, provides "that if an LGU is financially capable and has not exceeded the personal services (PS) limitation, the Local Sanggunian, may elevate the organization and staffing pattern of the Local Disaster Risk Reduction and Management Office (LDRMMO)." In Highly Urbanized Cities, the position title applicable to the head of LDRMMO shall be "City Government Department Head II";

**WHEREAS**, the Pasig City Human Resource Development Office recommends that an amendment to the position title of "Action Officer" be changed into "City Government Department Head II" for the purpose of complying with the above stated Joint Circular.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF PASIG IN A REGULAR SESSION DULY ASSEMBLED:**

**SECTION 1. AMENDMENT TO THE POSITION TITLE "ACTION OFFICER"** – The position title "Action Office" as used in Ordinance No. 2 series of 2019 is hereby amended as "City Government Department Head II" whose rank and benefits shall be that of the Department Head of the City.




**SECTION 2. REPEALING CLAUSE** – Any ordinance, resolution, and executive order inconsistent with this ordinance is hereby repealed.


**SECTION 3. EFFECTIVITY** – This ordinance shall take effect immediately.




