AN ORDINANCE APPROPRIATING THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) TO SERVE AS A CONTINGENCY FUND SHOULD THE LOCAL GOVERNMENT'S SHARE IN THE SUBSIDY OF CINEMA ADMISSION PRICES OF DULY REGISTERED SENIOR CITIZENS AND PERSONS WITH DISABILITY (PWD) IN PASIG CITY AND FOR OTHER PURPOSES.

WHEREAS, while it is the duty of the family to take care of its elderly members pursuant to Section 4 Article XV of the 1987 Philippine Constitution, the State may design programs of social security for them;

WHEREAS, the 1987 Philippine Constitution recognizes the importance of partnering with the private sector in the improvement of the welfare of senior citizens and PWD;

WHEREAS, in recognition of the rights and contributions of senior citizens and PWD's to society, the City Government of Pasig has decided to extend to them certain benefits, such as free admission to movie houses or cinemas;

WHEREAS, the Sangguniang Panlungsod has authorized the Honorable City Mayor Victor Ma. Regis N. Sotto to negotiate the terms of subsidizing admission tickets and to enter into Memoranda of Agreement with commercial establishments operating movie houses or cinemas within the City of Pasig;

WHEREAS, there is a need to assure the private sector that the City Government of Pasig is committed to meet its share in the subsidizing the admission of senior citizens and PWD's, even if the collectible amusement tax for the same period may be insufficient to offset such subsidy;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod in session assembled that:

SECTION 1. APPROPRIATION – The amount of Five Hundred Thousand Pesos (P500,000.00) is hereby appropriated as a contingency fund for the City Government Share in the cinema admission prices of senior citizens and PWD's, for which is to be taken from any available funds in the City Treasury, subject to existing COA rules and regulations; provided that this fund shall be used only if the share of the City Government of Pasig in the subsidy of cinema admission prices exceeds the collectible amount of Amusement Tax for the same period.




SECTION 4. EFFECTIVITY- This ordinance shall take effect immediately.


