SECTION 1. Section 2 of Ordinance No. 13, Series of 2019 is hereby amended to be read as follows:

SECTION 2. AIDS TO BARANGAY – Shall include assistance to Barangay Captain, Barangay Kagawad, Barangay Treasurer and Barangay Secretary, financial assistance given for every Brgy. cultural activities, supplies and materials, equipment, any kind of vehicles, all repairs pertaining to Brgy. except for the repair/rehabilitation of drainage system of the Barangay's.
