BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD NG PASIG, in session assembled that:

SECTION 1. Section 2 (d) of Ordinance No. 52, Series of 2018 is hereby amended to be read as follows:

D. "International Competitions" - refer to the recognized sports competitions internationally recognized namely Invitational Tournaments, Olympic Games, Quadrennial World Championship, Asian Games and Southeast Asian Games (SEA GAMES); Annual World Championships as recognized by sports world council.

SECTION 2. Section 3.5 and Section 5 of Ordinance No. 52, Series of 2018 is also amended to be read as follows:

SECTION 5. FUNDING FOR THE PROGRAM – the budgetary requirements to implement this Ordinance shall be chargeable to any available funds in the Treasury of the City Government of Pasig, subject to existing COA rules and regulations.

SECTION 3. SEPARABILITY CLAUSE – if for any reason, any provision or section or part of this ordinance is declared not valid by a Court of competent jurisdiction or suspended or veto by the City Mayor, such judgment shall not affect or impair the remaining provisions, section, or parts thereof, which shall remain or continue to be in full force and effect.






