WHEREAS, Article VIII, Section 336 of Ordinance No. 51, series of 2017 states that;

*"Section 336. Entry Inspection Fee – Carcasses, entrails / viscera from other slaughterhouses shall be inspected by the City at the following rates, regardless if frozen or fresh;*

Hog (whole)	P	300.00 / head
Cattle		500.00 / quarter
Poultry		0.60 / head
Head / pata / ears / ribs / bones		50.00 / kilo
Choice cuts and other parts		75.00 / kilo
Entrails / viscera / offal		50.00 / kilo

WHEREAS, in line with the policy of the present administration to reduce the taxes and regulatory fees and to provide more services to its constituents the foregoing sections of the said ordinance have to be amended.

NOW THEREFORE BE IT ORDAINED, in session assembled that:

SECTION 1. Section 336 of Ordinance No. 51, series of 2017 is hereby amended to be read as follows:

**SECTION 336. Entry Inspection Fee – Carcasses, entrails / viscera from other slaughterhouses shall be inspected by the City at the following rates, regardless if frozen or fresh;**

Beef / Carabeef (whole)	P	500.00
Beef / Carabeef (cut-ups per kg)		2.00
Pork / Chevon / Mutton (whole)		200.00
Pork / Chevon / Mutton (cut-ups per kg)		.60
Offals (entrails / viscera) – all kinds of meat per kg		2.00

**SECTION 2.** All traders of meat, meat products, poultry and poultry by-products and processed meat who are not accredited by the Pasig City Slaughterhouse are complied to submit the following prior to unloading/distribution of their products.


1. Pasig City Business Licensing Permit
2. Meat Handler's License Fee (Mayor's Occupational Permit)
3. Meat Transport Vehicle (MTV) Accreditation Fee
4. Order of Payment for the quantity of all meat and meat products
5. Official Receipt issued by the Market Cashier


**SECTION 3. REPEALING CLAUSE** – Any ordinance, resolution or executive order inconsistent with this Ordinance or any provision hereof is hereby repealed or amended.


**SECTION 4. EFFECTIVITY**- This Ordinance shall take effect fifteen days (15) after its publication in a newspaper of general circulation.
