**AN ORDINANCE GRANTING AMNESTY TO DELINQUENT TRAFFIC VIOLATORS WITHIN THE TERRITORIAL JURISDICTION OF PASIG CITY WITH UNREDEEMED IMPOUNDED UNITS, BY CONDONING THE TEN PESOS (P10) PER DAY IMPOSED BY SECTION 50 (T) OF ORDINANCE NO. 24 SERIES OF 2016 OTHERWISE KNOWN AS THE PASIG CITY REVISED TRICYCLE AND PEDICAB CODE OF 2016 AND FOR OTHER PURPOSES.**

**WHEREAS**, Section 192 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that local government units may, through ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary;

**WHEREAS**, Ordinance No. 24 series of 2016 otherwise known as the Pasig City Revised Tricycle and Pedicab Code of 2016 authorized the implementation and impoundment of tricycle and pedicab units to traffic violators in the City of Pasig;

**WHEREAS**, Section 50 (t) of the same Code accords a traffic violator a charge of Ten Pesos (P10) per day from the day of the impoundment until the redemption of the tricycle and/or pedicab unit/s;

**WHEREAS**, the grant of amnesty will give delinquent violators, most of whom are poor, the opportunity to redeem their confiscated tricycle and/or pedicab unit/s without the penalty imposed thereat, and to start working for their families and encourage them to settle their obligations;

**NOW, THEREFORE**, be it ordained by the Sangguniang Panlungsod of the City of Pasig, in session duly assembled, that:

**Section 1.** – There is hereby granted an amnesty to delinquent traffic violators within the territorial jurisdiction of Pasig City with unredeemed impounded units, by condoning the Ten Pesos (P10) per day imposed by Section 50 (t) of the Pasig City Revised Tricycle and Pedicab Code of 2016, subject to the following terms and conditions upon redemption, viz:

1. The violator must still pay the basic fine;
2. A violator with three (3) or more violations must undergo a seminar based on the provisions of the Pasig City Revised Tricycle and Pedicab Code of 2016.

**Section 2.** - The amnesty shall only be granted to those who were apprehended before the publication of this Ordinance.

**Section 3.** - The amnesty granted herein can only be availed of within six (6) months from the effectivity of this Ordinance.

**Section 4.** - Those units that will not be redeemed within the prescriptive period of this Ordinance will immediately be processed for auction by the City Government.


**Section 5.** - This Ordinance shall take effect fifteen days (15) after its publication in a newspaper of general circulation.
