AN ORDINANCE AMENDING ORDINANCE NO. 24 SERIES OF 2016 OTHERWISE KNOWN AS THE PASIG CITY REVISED TRICYCLE AND PEDICAB CODE OF 2016 AND FOR OTHER PURPOSES.

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 has mandated all local government units to provide the health, safety, comfort and convenience of all its inhabitants.

WHEREAS, the same Code authorizes the local government units to regulate public conveyances for hire or for private use, most especially tricycles and pedicabs;

WHEREAS, Ordinance No. 24 otherwise known as the Pasig City Revised Tricycle and Pedicab Code of 2016 comprehensively regulated the tricycles and pedicabs within and those passing by the jurisdiction of the City of Pasig;

WHEREAS, a special permit is a special privilege conferred by the City Government of Pasig to operators both for hire and for a particular service such as school service, delivery service, and market service or other similar services, which franchise are issued by adjacent local government units and non-residents of Pasig, respectively, for them to operate a motorized tricycle within the City of Pasig;

WHEREAS, there is a need to amend certain portions of said ordinance in order to serve the best interest of the riding public and ensure the benefits for the operators and drivers of the tricycles and pedicabs not only to those within the jurisdiction of the City of Pasig, but also to those adjacent local government units;

NOW, THEREFORE, BE IT ORDAINED, by the Sangguniang Panlungsod of the City of Pasig, in session duly assembled, that:

Section 1. – There is hereby repealed Section 47 of the said ordinance, and shall now be read as follows:

Fees and Charges – The charges to be imposed are as follows:

1. **TRICYCLE FOR HIRE**
 - a. Special Permit Fee P500.00/unit/quarter
 - b. Processing and Sticker P200.00 (one time payment)
 - c. Change of Unit P500.00 (one time payment)
2. **SCHOOL SERVICE/DELIVERY SERVICE/MARKET SERVICE**
 - a. Special Permit Fee P50.00/unit/month
 - b. Processing Fee and Sticker P100.00 (one time payment)
 - c. Change of Unit P100.00 (one time payment)

Section 2. – There is hereby repealed Section 52 of the said ordinance, and shall now be read as follows.

Liability of the Operator – The penalties imposed upon the operator is hereby removed except in cases of where the operator has control over the tricycle and/or pedicab unit, such as but not limited to the following,:

- a. Operating without franchise; and
- b. Improvised motor;
- c. Negligence in the maintenance of the tricycle in good running condition

Such operator shall pay the same amount of penalty under Section 50 of the Pasig City Revised Tricycle and Pedicab Code of 2016 and shall be solidarily liable with the driver concerned.

Section 3. – The Tricycle Operation Regulatory Office or TORO shall conduct seminars and/or trainingsto inform its enforcers about the changes in this ordinance shall further disseminate such information to the Tricycle Operator and Drivers Association within the City of Pasig.

Furthermore, the TORO is hereby tasked to coordinate to those adjacent cities which will be affected by this Ordinance.

Section 3. – All related ordinances in contrary to this Ordinance are hereby repealed.






