NOW THEREFORE BE IT ORDAINED, in session assembled that:

SECTION 1. Section 317 (a) and (c) of Ordinance No. 51, series of 2017 is hereby amended to be read as follows:

"Section 317. Imposition of Fees –

a) **Market Fees.** - The market fees for fixed stalls, booths, and tiendas as prescribed herein are on daily basis per square meter:

c) **Other Fees and Charges –**

SECTION 4. EFFECTIVITY- This Ordinance shall take effect immediately upon its approval.




