AN ORDINANCE AMENDING SECTION 22 OF ARTICLE VII, ARTICLE IX, SECTION 35 OF ARTICLE XII, SECTION 50, PARAGRAPH (I) OF ARTICLE XV, OF THE ORDINANCE NO. 24, SERIES OF 2016, OTHERWISE KNOWN AS "PASIG CITY REVISED TRICYCLE AND PEDICAB CODE OF 2016".

WHEREAS, Ordinance No. 24, Series of 2016, otherwise known as the Pasig City Revised Tricycle and Pedicab Code of 2016 was approved by the Sangguniang Panlungsod on 27 October 2016;

WHEREAS, the existing Code needs to be updated to keep up with the developments and changes in relation to the operation of tricycles and pedicabs in the City of Pasig;

WHEREAS, Article VII, Section 22, states: **Pasig City Tricycle/Pedicab Operation Regulatory Permit**. - This is the authority granted to operate the motorized tricycle "for service" and tricycle-pedicab "for service" within the City of Pasig designed to render service for a particular purpose with or without a fee such as but not limited to school-service, delivery service and market service or similar services to operate. The permit granted shall be non transferrable in all case;

WHEREAS, Article IX – Color Coding for Tricycle /Pedicab will add an additional Section;

WHEREAS, Article XII – Section 35, states: Tricycle and pedicab fares in Pasig City shall be determined by the Sangguniang Panlungsod through a resolution. The TORO shall recommend to the City Mayor and the Sangguniang Panlungsod any adjustment in the tricycle and pedicab fares.

WHEREAS, Article XV, Section 50, paragraph (i), states:

- I. Operating without franchise or with an expired franchise (COLORUM).
 - 1st Offense : Fine of One Thousand Pesos (Php 1,000.00) and impounding of the unit
 - 2nd Offense : Fine of One Thousand Five Hundred Pesos (Php 1,500.00) and impounding of the unit.
 - 3rd Offense : Fine of Two Thousand Pesos (Php 2,000.00) and impounding of the unit.

WHEREAS, the changes in this Code will serve not only the best interest of the riding public but also those of the operators and drivers of the tricycles and pedicabs in the City of Pasig.

NOW, THEREFORE, BE IT ORDAINED, by the Sangguniang Panlungsod of the City of Pasig, in session duly assembled, that:

Section 1. Article VII, Section 22, is hereby amended to be read as follows:

ARTICLE VII
PASIG CITY TRICYCLE / PEDICAB OPERATION
REGULATORY PERMIT

"Section 22. **Pasig City Tricycle / Pedicab Operation Regulatory Permit.** – This is the authority granted to operate the motorized tricycle "for service" and pedicab "for service" within the City of Pasig designed to render service for a particular purpose, with or without a fee, such as but not limited to school service, delivery service, market service, family use service, that are for private use for transport and others. The permit herein granted shall be non – transferable in all cases."

Section 2. Article IX (Color Coding for Tricycles / Pedicabs) is hereby added an additional section under, which shall be read as follows:

"Section 29. For Family Use Service. – A conspicuous NOT FOR HIRE and FOR FAMILY USE shall be indicated in the front and rear portions of the unit in yellow lettering. A navy blue color shall be painted in the body of the unit.

Section 3. Article XII, Section 35, is hereby amended to be read as follows:

"Section 35. The minimum jeepney fares as approved by the Land Transportation and Franchising Regulatory Board shall automatically be the basis of tricycle and pedicab fares, for the first kilometer and an additional One Peso (Php 1.00) for every succeeding kilometer.

The TORO is hereby tasked to formulate a new fare matrix for the "special trip" for all the TODA in the City of Pasig within fifteen (15) days upon effectivity of this Ordinance and submit it to the City Mayor for approval.

NO increase in fares will be implemented until the new matrix is placed in the tricycle, pedicab and terminals.

Section 4. Article XV, Section 50, paragraph (i), is hereby amended to be read as follows:

i. Operating without franchise or with an expired franchise (COLORUM).

1st Offense : Fine of Two Thousand Pesos (Php 2,000.00) and impounding of the unit for Three (3) working days.

2nd Offense : Fine of Three Thousand Pesos (Php 3,000.00) and impounding of the unit for Five (5) working days.

3rd Offense : Fine of Five Thousand Pesos (Php 5,000.00) and impounding of the unit for Ten (10) working days.

Provided, all impounded units in this section shall be charged Ten Pesos (Php 10.00) as stated in Section 50, paragraph (t), of the same Code, only after the abovementioned penalties have been served.

Section 5. Section 29 of Ordinance No. 24, series of 2016 is hereby renumbered as Section 30 and is hereby renumbered as follows:

Section 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40, 41, 42, 43, 44, 45, 46, 47, 48, 49, 50, 51, 52, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, and 63 of Ordinance 24, series of 2016 are hereby renumbered Sections 31, 32, 33, 34, 35, 36, 37, 38, 39, 40, 41, 42, 43, 44, 45, 46, 47, 48, 49, 50, 51, 52, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, 63 and 64 respectively.

Section 6. Repealing Clause – All ordinances, executive order, rules and regulations, or parts thereof, in conflict with or consistent with any of the provision of this ordinance are hereby repealed or modified accordingly.

Section 7. Effectivity – This ordinance shall take effect immediately upon publication in a newspaper of general circulation.
