AN ORDINANCE PROHIBITING THE SELLING AND DRINKING OF ALCOHOLIC DRINKS IN ESTABLISHMENTS AND PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF PASIG CITY DURING THE STATE OF NATIONAL EMERGENCY, PROVIDING PENALTIES FOR VIOLATION THEREFOR AND FOR OTHER PURPOSES.

WHEREAS, Section 5, Article 11 of the 1987 Constitution provides that, "the maintenance of peace and order, the protection of life and property, and the promotion of the general welfare are essential for the enjoyment of democracy among all people;

WHEREAS, on March 15, 2020, the City Government of Pasig declared a State of Calamity in the entire City in order to prevent the continued and accelerated spread of the COVID-19 pandemic;

WHEREAS, on March 17, 2020, President Rodrigo R. Duterte placed the entire Philippines under an enhanced State of National Emergency because of COVID-19 pandemic;

WHEREAS, Section 16 of R.A. 7160 otherwise known as the Local Government Code of 1991 states that, "every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 458 paragraph (a) sub-paragraph (1) (v) of the same code provides that, the Sangguniang Panlungsod, being the legislative body of the City shall enact ordinances intended to prevent, suppress and impose appropriate penalties for habitual drunkenness in public places, and such other activities inimical to the welfare and morals of the inhabitants of the city;

WHEREAS, there are reports from various barangays that social drinking of alcoholic beverages still persists in public places despite the enhanced community quarantine;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD NG PASIG IN SESSION ASSEMBLED.

SECTION 1. TITLE. – This Ordinance shall be referred to as the “Liquor Ban during the state of national emergency in Pasig City”

SECTION 2. DECLARATION OF POLICY

It is the policy of the Local Government of Pasig to protect its citizenry from such activities unfavorable to their welfare and well-being and to safeguard their safety and health by maintaining peace and order in every barangay in this City.

SECTION 3. DEFINITION OF TERMS

1. Beverages, distilled or fermented, but not limited to beer, whiskey, rum, gin, brandy, or other locally fermented wines such as tuba, basi and the likes will be defined as alcoholic drinks.

2. Public Place shall refer to all places accessible to the public such as Sari-sari stores, public street, sidewalk, park, plaza, square, parkway, alley, callejon, other open space outside of residential perimeter and other similar public places.

“Other similar public places” shall include those privately owned compound without any fence and visible to public view.

3. Sari-sari Stores, Convenience Stores, Grocery Stores, Supermarkets, Restaurant, Panciteria, Hotel, or Bar and other enclosed structures will be defined as establishments.

SECTION 4. PROHIBITED ACTS

1. The selling or serving of any alcoholic drinks by an establishment whether licensed or not, is **STRICLY PROHIBITED** within the territorial jurisdiction of Pasig City.

2. Drinking of any alcoholic drinks in public places within the territorial jurisdiction of Pasig City is also **PROHIBITED**.

SECTION 5. PENAL PROVISION

Any person or establishment violating the provisions of this Ordinance shall be punished by the following fines, for establishments; the owner or the manager will perform the community service to wit:

First Offense: Fine of Five Hundred Pesos (P500.00) or four (4) hours community service.

Second offense: Fine of One Thousand Pesos (P1,000.00) or eight (8) hours community service.

Third Offense: Fine of Two Thousand Pesos (P2,000.00) or sixteen (16) hours community service and imprisonment of not less than one (1) month or not less than three (3) months or both at the discretion of the court.

SECTION 6. IMPLEMENTATION.

The Office of Public Safety (OPS), the Batas ng Ciudad Enforcement Office (BCEO), the Philippine National Police, Barangay Officials and Security Forces (BSF) are hereby tasked to implement and enforce the provisions of this Ordinance.

SECTION 7. SEPARABILITY CLAUSE.

If, for any reason, any part or provision of this ordinance shall be declared unconstitutional or invalid, other parts or provisions not affected thereby shall continue to be in full force and effect.

SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon approval due to the urgency of the concerns caused by the COVID-19 pandemic. Should the declared state of national emergency be lifted, the regulations imposed in this Ordinance shall be suspended accordingly.
