WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as Local Government Code of 1991 provides that, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, on 9 March 2020 President Rodrigo R. Duterte issued Proclamation No. 922 declaring a State of Public Health Emergency throughout the country;

WHEREAS, the Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF), through Resolution No.11, Series of 2020 dated 12 March 2020 raised the Code Alert system for COVID-19 to Code Red Sub-level 2 and recommended strict social distancing, suspension of classes, limiting of mass gatherings, community quarantine, limiting of work in the executive branch of government and promoting flexible work arrangements for a period of thirty (30) days in the National Capital Region;

WHEREAS, Executive Order No. PCG-12, Series of 2020 entitled: An Executive Order for the Management and Control of the Coronavirus Disease 2019 (COVID-19) and for Other Purposes issued on 13 March 2020 mandated the imposition of community quarantine and placing the entire City under State of Calamity;

WHEREAS, on April 3, 2020, the Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF) recommended that for areas placed under ECQ [enhanced community quarantine], the IATF hereby adopts the policy of mandatory wearing by all residents of face masks, whenever allowed to go out of their residences pursuant to existing guidelines issued by the national government.

SECTION 1. SHORT TITLE. This Ordinance shall be known as "Mandatory Wearing of Face Masks".

SECTION 2. DECLARATION OF POLICY. It shall be the policy of the Local Government of Pasig to strictly require the mandatory wearing by all residents of face masks, whenever allowed to go out of their residences and on public places within the territorial jurisdiction of Pasig City.

SECTION 3. UNLAWFUL ACTS. It shall be unlawful for any person, whether natural or juridical to refuse the mandatory wearing of face mask when going out of the residences or as may be required by any establishment and on public places within the territorial jurisdiction of Pasig City.

A public officer who refuses to wear face mask shall also be liable under the Ordinance and the penalty shall be imposed thereon.

SECTION 4. PENALTIES. Any person in violation of Section 3 shall be fined in the amount of Five Hundred Pesos (P500.00) or imprisonment not exceeding two (2) months or both at the discretion of the court.

If committed by a juridical person, the penalty shall be imposed to the Corporation, Partnership or Association unless otherwise provided by law.

SECTION 5. SEPARABILITY CLAUSE. Should any article, section or regulation of this Ordinance be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of the Ordinance as a whole, or any portion thereof other than the article, section or regulation so declared to be unconstitutional or invalid.

SECTION 6. REPEALING CLAUSE. All ordinances or portions of ordinances in conflict with this Ordinance, or inconsistent with the regulations of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

SECTION 7. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon its approval.
