**AN ORDINANCE REPEALING ORDINANCE NO. 08, SERIES OF 2020 ENTITLED "AN ORDINANCE PROHIBITING THE SELLING AND DRINKING OF ALCOHOLIC DRINKS IN ESTABLISHMENTS AND PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF PASIG CITY DURING THE STATE OF NATIONAL EMERGENCY, PROVIDING PENALTIES FOR VIOLATION THEREFOR AND FOR OTHER PURPOSES".**

**WHEREAS**, on March 9, 2020, President Rodrigo R. Duterte issued Proclamation No. 922, declaring the State of Public Health Emergency throughout the Philippines due to the Corona Virus Disease 2019 (COVID-19). Likewise, Proclamation No. 929, Series of 2020 was subsequently issued, declaring a State of Calamity throughout the Philippines due to COVID-19;

**WHEREAS**, in relation to the declaration of the State of Public Health Emergency, the National Government imposed strict social distancing, suspension of classes, limiting of mass gatherings, community quarantine, limiting of work in the executive branch of government and promoting flexible work arrangements and temporary closure of business establishment that is not considered as provider of essential goods or services;

**WHEREAS**, on March 16, 2020, to prevent the sharp rise of COVID-19 cases in the country, the President placed the entirety of Luzon under Enhanced Community Quarantine ("ECQ") until April 14, 2020, which subsequently extended to May 15, 2020;

**WHEREAS**, in response to the declaration of the National Government, the City Government of Pasig passed and implemented City Ordinance No. 8, Series of 2020, otherwise known as "Liquor Ban During the State of National Emergency in Pasig City" as one of its measures to prevent the spread of COVID-19 within its territorial jurisdiction;

**WHEREAS**, the said ordinance sought to strictly impose social distancing, avoid mass gathering and to prevent social drinking of alcoholic beverages in public places despite the declaration ECQ;

**WHEREAS**, on May 11, 2020, Inter Agency Task Force for the Management of infectious Diseases (IATF) through Resolution No. 35, Series of 2020, declares that highly urbanized cities in National Capital Region be placed under Modified Enhanced Community Quarantine (MECQ) effective May 16 until May 31, 2020;

**WHEREAS**, the City Government of Pasig deems it necessary to lift the liquor ban within its territorial jurisdiction subject to the guidelines issued by the IATF, by taking into consideration the interest of business establishments especially those affected during ECQ and implementation of liquor ban.

**NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD NG PASIG, IN SESSION DULY ASSEMBLED, THAT:**

**SECTION 1. SHORT TITLE.** – This ordinance shall be referred to as the "Providing Guidelines for the Lifting of Liquor Ban in the City of Pasig".

**SECTION 2. SELLING AND DRINKING.** – All establishments that sell alcoholic drinks, including but not limited to Sari-Sari Stores, Convenience Stores, Grocery Stores, Supermarkets, Restaurants, *Panciteria*, Hotel, or Bar and other enclosed structures must strictly follow the policies, issuances and guidelines issued by the National Government and the City Government of Pasig with respect to their operation.

**SECTION 3.** Ordinance No. 54, S-2017 entitled "An Ordinance amending City Ordinance No. 01, Series of 2013, An Ordinance prohibiting the drinking of beer, liquor or intoxicative beverages in "Sari-Sari Store, Street, Sidewalk, Alley, Callejon, Park, Plaza or other similar public places"." shall still be in effect.

**SECTION 4.** All Inter-Agency Task Force (IATF) Resolutions regarding Bars, Restaurants and places of Amusements shall be implemented.

**SECTION 5. REPEALING CLAUSE.** – All ordinances, executive order, rules and regulations, or parts thereof, in conflict with or consistent with any of the provision of this ordinance are hereby repealed or modified accordingly.

**SECTION 6. SEPARABILITY CLAUSE.** – If, for any reason, any part or provision of this ordinance shall be declared unconstitutional or invalid, other parts or provisions not affected thereby shall continue to be in full force and effect.

**SECTION 7. EFFECTIVITY.** –This Ordinance shall take effect this 26<sup>th</sup> of May 2020. Should the declared state of national emergency be lifted, the regulations imposed in this Ordinance shall be suspended accordingly.
