WHEREAS, there is a need to revert the appropriation of **ONE HUNDRED SIXTY TWO MILLION FOUR HUNDRED THOUSAND THREE HUNDRED TWENTY EIGHT PESOS & 20/100 (Php162,400,328.20)** in order to finance priority projects, programs and expenditure to fight COVID 19 for the Calendar Year 2020;

Section 1. Reversion of Fund – There is hereby reverted the sum of **ONE HUNDRED SIXTY TWO MILLION FOUR HUNDRED THOUSAND THREE HUNDRED TWENTY EIGHT PESOS & 20/100 (Php162,400,328.20)** representing the savings of the City of Pasig.
