WHEREAS, the City Government of Pasig recognizing the grave threat to the health, security, and lives of its constituents due to the coronavirus disease 2019("COVID-19"), strongly resolves to adopt various measures in the pursuit of suppressing the pandemic within its jurisdiction. To address the needs of the populace, the City Government has consistently and continuously adopted innovative measures, within the scope of and in adherence to the directives of the National Government;

WHEREAS, the City Government of Pasig, through its *Sangguniang Panlungsod* enacted Ordinance No. 15, Series of 2020, otherwise known as "Barangay Coding Scheme", as one of its measures against the COVID-19 disease, which imposed a schedule for each barangay to regulate the mobility of its residents, to ensure quarantine protocol and social distancing;

WHEREAS, Section 11 of the said ordinance provides for a penalty of **Five Thousand Pesos(P5,000.00)and/or imprisonment of six (6) months upon the discretion of the proper court**for violating any of its provisions. Further, that said ordinance needs an amendment in recognition of humane consideration, given the situation during this pandemic;

NOW, THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG CITY, IN SESSION DULY ASSEMBLED:

SECTION 1. AMENDMENT – Section 11 of Ordinance No. 15, Series of 2020, is hereby amended to be read as follows:

Any person, natural or juridical, found guilty of this Ordinance shall be meted a penalty of **One Thousand Pesos (P1,000.00) or forty (40) hours of community service.**

SECTION 2.EFFECTIVITY.– This ordinance shall take effect immediately. Further, the provisions of this ordinance shall retroact and be given effect from the effectivity of Ordinance No. 15, Series of 2020.




