WHEREAS, on March 9, 2020, President Rodrigo R. Duterte issued Proclamation No. 922, declaring the State of Public Health Emergency throughout the Philippines due to the Coronavirus Disease 2019 ("COVID-19"). Likewise, Proclamation No. 929, Series of 2020 was subsequently issued, declaring a State of Calamity throughout the Philippines due to COVID-19;

WHEREAS, on 16 March 2020, the national government declared that the entire Luzon be placed under Enhanced Community Quarantine ("ECQ") to prevent the proliferation of COVID-19 pandemic which affected business establishments including the distribution of basic necessities and personal protective gears due to various check points set-up by Philippine National Police for the purpose of preventing non-essential travel within Luzon;

WHEREAS, the Department of Trade and Industry has issued a warning that there is no need to panic-buy and asked the business establishments such as grocery and supermarket owners to limit the quantity of items they are selling in light of the panic buying caused by the COVID-19;

WHEREAS, the City Government of Pasig through the *Sangguniang Panlungsod* enacted Ordinance 07, Series of 2020, otherwise known as "Anti-Hoarding and Anti-Panic Buying Ordinance of Pasig City", aimed to protect the public particularly its constituents, against the possible abuse of persons and business entities by unreasonable hoarding of basic and prime commodities, including face mask, alcohol for sanitation and other products that are being used to avoid the disease;

WHEREAS, on 1 June 2020, the Inter-Agency Task Force for the Management of Emerging Infectious Disease, placed the Highly Urbanized Cities in Metro Manila under General Community Quarantine ("GCQ") which implement a more relaxed quarantine protocols and measures and resulted to a more stable of distribution of basic and prime commodities in business establishments;

NOW, THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG CITY, IN SESSION DULY ASSEMBLED:

SECTION 1. LIFTING. – Ordinance No. 07, Series of 2020, otherwise known as "Anti-Hoarding and Anti-Panic Buying Ordinance of Pasig City" is hereby lifted.

SECTION 2. EFFECTIVITY. – This ordinance shall take effect immediately upon approval.
