WHEREAS, RA No. 11466 otherwise known as the "Salary Standardization Law of 2019", modifies the Salary Schedule for the implementing the revised compensation and position classification system in the Local Government Units;

WHEREAS, the aforementioned RA No. 11466 states that there is an immediate need to update the compensation structure of the government personnel. Thus, it is imperative to upgrade and further rationalize the present compensation system;

WHEREAS, the Department of Budget and Management (DBM) issued Local Budget Circular No. 121 dated January 24, 2020, specifying the Guidelines necessary for the implementation of RA No. 11466;

WHEREAS, it is necessary that an amount be appropriated for the purpose herein stated.

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG, IN SESSION DULY ASSEMBLED THAT:

Section 1. The amount necessary for the implementation of RA No. 11466, issued January 8, 2020, is hereby appropriated as compensation adjustment for the employees of the City Government of Pasig and in pursuant to Local Budget Circular No. 121 of the Department of Budget and Management, funds to be taken out from the approved Executive Budget CY 2020, the Salary Savings and from other sources available in the City Treasurer.

Section 2. The City Treasurer and the Budget Officer are hereby directed to implement this Ordinance pursuant to the provisions of the above RA No. 11466 and in accordance with the implementing guidelines issued by the Department of Budget and Management (DBM) Local Budget Circular No. 121 dated January 24, 2020, subject to all legal and auditing rules and procedures.

Section 3. The implementation of this compensation adjustment is retroactive to January 1, 2020.


Section 4. This Ordinance shall take effect immediately upon its approval.






