AN ORDINANCE WAIVING THE RENTAL FEES, CHARGES, AND PENALTIES INCURRED BY LEGITIMATE KIOSK AND CANTEEN TENANTS LOCATED WITHIN THE VICINITY OF PASIG CITY HALL FOR THE MONTHS OF APRIL TO JUNE 2020 AND FOR OTHER PURPOSES.

WHEREAS, on March 9, 2020, President Rodrigo R. Duterte issued Proclamation No. 922, declaring the State of Public Health Emergency throughout the Philippines due to the Coronavirus Disease 2019 (COVID-19). Likewise, Proclamation No. 929, Series of 2020 was subsequently issued, declaring a State of Calamity throughout the Philippines due to COVID-19;

WHEREAS, in relation to the declaration of the State of Public Health Emergency, the National Government imposed strict social distancing, suspension of classes, limiting of mass gatherings, community quarantine, limiting of work in the executive branch of government and promoting flexible work arrangements and temporary closure of business establishment that is not considered as provider of essential goods or services;

WHEREAS, on March 16, 2020, to prevent the sharp rise of COVID-19 cases in the country, the President placed the entirety of Luzon under Enhanced Community Quarantine until April 14, 2020, which subsequently extended to May 15, 2020;

WHEREAS, on May 11, 2020, Inter Agency Task Force for the Management of infectious Diseases through Resolution No. 35, Series of 2020, declares that highly urbanized cities in National Capital Region ("NCR") be placed under Modified Enhanced Community Quarantine effective May 16 until May 31, 2020. Subsequently, a General Community Quarantine was implemented starting 01 June 2020, which provides a less strict community quarantine and allowed several operations of businesses in the NCR;

WHEREAS, Section 16 of Republic Act No. 7160, also known as the Local Government Code of 1991, provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

AN ORDINANCE WAIVING THE RENTAL FEES, CHARGES, AND PENALTIES INCURRED BY LEGITIMATE KIOSK AND CANTEEN TENANTS LOCATED WITHIN THE VICINITY OF PASIG CITY HALL FOR THE MONTH OF APRIL TO JUNE 2020 AND FOR OTHER PURPOSES.

WHEREAS, all of the kiosk and canteen tenants ("tenants") within the vicinity of Pasig City Hall closed their stalls and did not resume the operation of their businesses until the latter part of the month of June 2020, and were greatly affected when the rental fees, charges, and penalties due to the City Government accumulated during the community quarantine;

WHEREAS, to ease the burden of the tenants, the City Government of Pasig, deems it necessary to extend aid to the tenants in the form of waiving the rental fees, charges, and penalties incurred by them during the community quarantine.

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF THE CITY OF PASIG IN SESSION DULY ASSEMBLED, THAT:

SECTION 1. APPLICABILITY. - This ordinance shall apply only to legitimate kiosk and canteen tenants located **within** the vicinity of Pasig City Hall.

SECTION 2. WAIVER OF RENTAL FEES. - The rental fees and charges of legitimate tenants for the months of April, May, and June 2020 are hereby waived. For the purpose of this ordinance, charges are those imposed and levied by the City Government of Pasig as provided under Ordinance No. 51, series of 2017, otherwise known as the 2017 Revised Pasig Revenue Code.

SECTION 3. WAIVER OF PENALTIES. - The penalties incurred by the tenants for the non-payment of the rental fees and charges for the months specified in the preceding section are further waived.

SECTION 4. IMPLEMENTING OFFICE. - The Office of the City Treasurer is authorized to use a system that will enable the waiving of rental fees, charges, and penalties as provided hereof.

SECTION 5. PENALTIES. - Any person found guilty for violation hereof shall be penalized under the provisions as provided in the 2017 Revised Pasig Revenue Code.

SECTION 6. SEPARABILITY CLAUSE. - If for any reason, any section or provision of this Ordinance is held to be unconstitutional or invalid by competent authority, such judgement or action shall not affect or impair the other sections or provisions hereof.


SECTION 7. EFFECTIVITY. -This Ordinance shall take effect immediately.


