**AN ORDINANCE AMENDING SECTION 4 OF ORDINANCE NO. 34, SERIES OF 2020 OTHERWISE KNOWN AS "THE UNIFORM CURFEW ORDINANCE OF PASIG CITY 2020", AND FOR OTHER PURPOSES.**

**WHEREAS**, Presidential Proclamation No. 929 was issued on 16 March 2020 declaring a state of calamity throughout the Philippines due to the Corona Virus Disease 2019 (COVID-19) enjoining all government agencies and local government units (LGUs) to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the threat of COVID-19;

**WHEREAS**, the City Government of Pasig, in adherence to the guidelines issued by the national government, implemented various measures to prevent the further spread of the disease within its territorial jurisdiction;

**WHEREAS**, on 5 August 2020 the Sangguniang Panlungsod of Pasig enacted Ordinance No. 34, Series of 2020 otherwise known as "The Uniform Curfew Ordinance of Pasig City 2020", that imposed a uniform curfew hour during the implementation of community quarantine;

**WHEREAS**, the purpose of the said ordinance is to set a uniform curfew schedule that will automatically apply when a community quarantine status is declared by the national government with the application of the curfew will be immediate and executor without need for a prior announcement from the City Government of Pasig;

**WHEREAS**, on 17 August 2020 President Rodrigo Roa Duterte announced that cities in Metro Manila will be placed under General Community Quarantine from August 19 – 31, 2020.

**WHEREAS**, as per observation, the less stringent measures attendant to General Community Quarantine results in more cases of unnecessary travel and loitering during the night hours, which defeats the purpose of community quarantine, and hence, there is a need to impose a longer curfew hours in order to prevent the community from going outside their residence without any essential purpose.

**NOW, THEREFORE, BE IT ORDAINED AS IT IS ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG, IN SESSION DULY ASSEMBLED THE FOLLOWING:**

AN ORDINANCE AMENDING SECTION 4 OF ORDINANCE NO. 34, SERIES OF 2020 OTHERWISE KNOWN AS "THE UNIFORM CURFEW ORDINANCE OF PASIG CITY 2020", AND FOR OTHER PURPOSES.

**SECTION 1. AMENDMENT.** – Section 4 of Ordinance No. 34, Series of 2020 otherwise known as "The Uniform Curfew Ordinance of Pasig City 2020," is hereby amended and to be read as follows:

**'Section 4. CITY WIDE UNIFORM CURFEW.** – The curfew hour in City of Pasig shall be from 8:00 o'clock in the evening to 5:00 o'clock in the morning of the following day, regardless of the community quarantine status implemented within its territorial jurisdiction.

The directed times of curfew are without prejudice to any national or local government issuance particularly dictating a different time or day of curfew. In case of conflict between a later national or local government issuance and this Ordinance, the former will govern."


**SECTION 2. REPEALING CLAUSE.** – All ordinances or portions of ordinances in conflict with this Ordinance, or inconsistent with the regulations of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

**SECTION 3. EFFECTIVITY.** – This Ordinance shall take effect immediately upon its approval.




