WHEREAS, Presidential Proclamation No. 929 was issued on 16 March 2020 declaring a state of calamity throughout the Philippines due to the Corona Virus Disease 2019 ("COVID-19") enjoining all government agencies and local government units (LGUs) to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the threat of COVID-19;

WHEREAS, the City Government of Pasig, in adherence to the guidelines issued by the national government, implemented various measures to prevent the further spread of the disease within its territorial jurisdiction;

WHEREAS, on 5 August 2020 the Sangguniang Panlungsod of Pasig enacted Ordinance No. 34, Series of 2020 otherwise known as "The Uniform Curfew Ordinance of Pasig City 2020", that imposed a uniform curfew hour during the implementation of community quarantine;

WHEREAS, the purpose of the said ordinance is to set a uniform curfew schedule that will automatically apply when a community quarantine status is declared by the national government with the application of the curfew will be immediate and executor without need for a prior announcement from the City Government of Pasig;

WHEREAS, on 31 August 2020 President Rodrigo Roa Duterte announced that cities in Metro Manila will be placed under General Community Quarantine from September 1 – 30, 2020.

WHEREAS, according to the Office of the Presidential Spokesperson's press briefing held on 01 September 2020, with the concurrence of all the chief executives of Metro Manila, they agreed to shorten the curfew hours with the intention to slowly open up the economy.

Amfamm NOW, THEREFORE, BE IT ORDAINED AS IT IS ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG, IN SESSION DULY ASSEMBLED THE FOLLOWING:

SECTION 1.AMENDMENT. – Section 4 of Ordinance No. 34, Series of 2020 otherwise known as "The Uniform Curfew Ordinance of Pasig City 2020," is hereby amended and to be read as follows:

SECTION 4. CITY WIDE UNIFORM CURFEW. – The curfew hours in City of Pasig shall be from **10:00 o'clock in the evening to 5:00 o'clock in the morning** of the following day, regardless of the community quarantine status implemented within its territorial jurisdiction.

Provided, if public interest so requires, or there is a valid order from the national government, the City Mayor shall have the authority to adjust the schedule of the curfew hours by the issuance of an executive order.

Provided, further, this provision shall only valid during the national emergency as declared by the national government and may only be lifted by the same.

SECTION 2.REPEALING CLAUSE. – All ordinances or portions of ordinances in conflict with this Ordinance, or inconsistent with the regulations of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

SECTION 3. EFFECTIVITY. – This Ordinance shall take effect immediately upon its approval.
