AN ORDINANCE AMENDING ORDINANCE NO. 03, SERIES OF 2021 ENTITLED " AN ORDINANCE GRANTING AMNESTY TO DELIQUENT TAXPAYERS OF REAL PROPERTY TAXES, IDLE LAND TAXES, BUSINESS TAXES AND REGULATORY FEES FOR TAXABLE YEAR 2020 AND PRIOR YEARS BY CONDONING THE PAYMENT OF PENALTIES, SURCHARGES, AND INTEREST, AND FOR OTHER PURPOSES".

WHEREAS, on January 28, 2021 the Sangguniang Panlungsod of Pasig enacted Ordinance No. 03, Series of 2021 entitled, "AN ORDINANCE GRANTING TAX AMNESTY TO DELIQUENT TAXPAYERS OF REAL PROPERTY TAXES, IDLE LAND TAXES, BUSINESS TAXES AND REGULATORY FEES FOR TAXABLE YEAR 2020 AND PRIOR YEARS BY CONDONING THE PAYMENT OF PENALTIES, SURCHARGES, AND INTEREST, AND FOR OTHER PURPOSES".

WHEREAS, the said Ordinance granted the City of Government of Pasig the authority to grant tax amnesty to delinquent taxpayers of real property, idle land taxes, business taxes and regulatory fees for year 2020 and all prior years that have remained unpaid as of December 31, 2020, provided that the basic taxes must be paid with or without assessment;

WHEREAS, the City Treasurer of the City Government of Pasig recommended that the transfer tax for real property and tax obligations of Philippine Economic Zone Authority accredited businesses due to the City Government must be included in the amnesty ordinance.

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Pasig, in session duly assembled that:

Section 1. – TITLE. The title of Ordinance No. 03, Series of 2021 is hereby amended and to be read now as follows:

"AN ORDINANCE GRANTING TAX AMNESTY TO DELIQUENT TAXPAYERS OF REAL PROPERTY TAXES, IDLE LAND TAXES, BUSINESS TAXES, REGULATORY FEES, TRANSFER TAXES FOR REAL PROPERTY AND TAXES PAID BY THE PHILIPPINE ECONOMIC ZONE ACCREDITED ACCREDITED BUSINESSES TO THE CITY GOVERNMENT OF PASIG FOR TAXABLE YEAR 2020 AND PRIOR YEARS BY CONDONING THE PAYMENT OF PENALTIES, SURCHARGES, AND INTEREST, AND FOR OTHER PURPOSES."

Section 2. – GRANT OF TAX AMNESTY. The grant of tax amnesty provided in Section 1 of Ordinance No. 03, Series of 2021 is hereby amended and to be read now as follows:

"Section 1. – GRANT OF TAX AMNESTY. The City Government of Pasig is hereby authorized to grant tax amnesty to delinquent taxpayers of Real Property Taxes, Idle Land Taxes, Business Taxes, Regulatory Fees, Transfer Taxes of Real Property and Taxes paid by the Philippine Economic Zone Authority accredited businesses to the City Government of Pasig for the year 2020 and all prior years that have remained unpaid as of December 31, 2020."

Section 3. – COVERAGE OF AMNESTY. The coverage of amnesty provided in Section 2 of Ordinance No. 03, Series of 2021 is hereby amended and to be read now as follows:

"Section 2. – COVERAGE OF AMNESTY. There shall be condonation as regards to the payment of penalties, surcharges, and interests on unpaid Real Property Taxes, Idle Land Taxes, Business Taxes and Regulatory Fees such as but not limited to Sanitary Inspection Fee, Environmental Inspection Fee, Garbage Fee and EPO Accreditation Fee, Transfer Taxes of Real Property and Taxes paid by the Philippine Economic Zone Authority accredited businesses to the City Government of Pasig. However, the basic taxes shall be paid, with or without assessment."

Section 4. – SEPARABILITY CLAUSE. If any part or provision of this Ordinance is held invalid or unconstitutional, other provisions not affected thereby shall remain in force and effect.

Section 5. – REPEALING CLAUSE. All other ordinances, rules and regulations or parts thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

Section 6. – EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.
