AN ORDINANCE EXTENDING THE DEADLINE FOR THE PAYMENT OF RENTAL FEES, ELECTRICAL AND WATER CONSUMPTION OF ALL STALLHOLDERS OF PASIG MEGA MARKET FOR THE MONTHS OF MAY AND JUNE 2021 TO JUNE 30, 2021 AND FOR OTHER PURPOSES.

WHEREAS, Section 16 of Republic Act No. 7160, also known as the Local Government Code of 1991, provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, stallholders particularly those located at the 2nd floor of Pasig Mega Market is having a hard time to recover from the adverse effect of COVID-19 on their income as they are not considered as essential. In line with this, they requested to extend the deadline in the payment of rental fee including the payment of their monthly consumption on electric and water bills without the prescribed penalties thereof;

WHEREAS, Section 320 of Ordinance No. 51, Series of 2017 otherwise known as the Revised Revenue Code of Pasig, provides that "the monthly fees for the use of market stall booth or space, electricity and/or water shall always be paid within the first twenty (20) days of each month";

WHEREAS, to ease the burden of the stallholders the City Government of Pasig deems it necessary to extend an aid to the stallholders in form of extending their deadline for the payment of rental fee, electric and water consumption.

NOW, THEREFORE, THE SANGGUNIANG PANLUNGSOD RESOLVES, AS IT HEREBY RESOLVED, THAT:

SECTION 1. APPLICABILITY. – This ordinance shall apply to all legitimate stallholders of the Pasig Mega Market.

AN ORDINANCE EXTENDING THE DEADLINE FOR THE PAYMENT OF RENTAL FEES, ELECTRICAL AND WATER CONSUMPTION OF ALL STALLHOLDERS OF PASIG MEGA MARKET FOR THE MONTHS OF MAY AND JUNE 2021 TO JUNE 30, 2021 AND FOR OTHER PURPOSES.

For this purpose, legitimate stallholders are those persons who rent a stall, booths, or tiendas and are paying monthly electric and water bills to the City Government of Pasig and those who complied with the requirements as stated in Ordinance No. 51, Series of 2017, otherwise known as the Revised Revenue Code of Pasig.

SECTION 2. EXTENSION OF PAYMENT. – The deadline for the payment of rental fees, electric and water consumption of legitimate stallholders for the months of May and June 2021, is hereby moved to June 30, 2021.

SECTION 3. IMPLEMENTING OFFICE. – The Office of the City Treasurer in coordination with the Market Administration Office is hereby authorized to use a system that will enable the extension of deadline for the payment of rental fees, electric and water consumption for the legitimate stallholders subject of this ordinance.

SECTION 4. PENALTY. – Failure of legitimate stallholders to pay within the period mentioned in Section 2 of this Ordinance, shall result to the automatic imposition of penalty provided by the Revised Revenue Code of Pasig City.

SECTION 5. SEPARABILITY CLAUSE. – If for any reason, any section or provision of this Ordinance is held to be unconstitutional or invalid by competent authority, such judgement or action shall not affect or impair the other sections or provisions hereof.

SECTION 6. EFFECTIVITY. – This Ordinance shall take effect immediately.
