WHEREAS, Section 17 (b) (2) (viii) and Section 17 (b) (3) (vii) in relation to Section 17 (b) (4) of Republic Act No. 7160 provide that, the City has the duties and responsibility of constructing infrastructure facilities intended primarily to service the needs of its residents including the construction of roads, multi-purpose buildings, housing facilities, among others;

WHEREAS, Section 19 of the same code further provides that, a local government unit may, through its chief executive and acting pursuant to an ordinance, exercise the power of eminent domain for public use, or purpose, or welfare for the benefit of the poor and the landless, upon payment of just compensation.

WHEREAS, the property of Dominga L. Asuncion, Carlos L. Asuncion, Pilar Fuentes Asuncion, Wilhelmina F. Asuncion-Mondez, Angelito F. Asuncion, Marianito F. Asuncion, Edelwina F. Asuncion, Florcerfina F. Asuncion-Perry, Armando F. Asuncion, Cesar F. Asuncion, Jr., Joselito F. Asuncion, Emmanuel F. Asuncion, Eduardo P. Giron, Brian A. Giron, Marah A. Giron, Renato A. Asuncion And Ma. Socorro A. Asuncion, covered by Transfer Certificate of Title No. 011-2015000321 with an area of Five Hundred (500) square meters, more or less, located in INT. J.B. SECTION 1. –The Honorable City Mayor Victor Ma. Regis N. Sotto is hereby authorized to negotiate and/or initiate expropriation proceedings, as the case maybe as hereunder provided, for the acquisition of the subject property registered under Transfer Certificate of Title No. 011-2015000321 , with a total area of Five Hundred (500) square meters, more or less, located in INT J.B. Miguel St.,

Barangay Bambang, Pasig City, to be used for on site development housing program of the City Government of Pasig, and the payment of the purchase price or just compensation thereof to the registered owner, as the case may be.

For this purpose, the City Mayor may authorize the Office of the City Legal Officer – Pasig City or Office of the City Mayor to represent him in making the written offers and in negotiating with the affected owners.

SECTION 2. – The City Mayor is further authorized in case of a negotiated sale to pay the purchase price for the subject property, as agreed upon by the parties, and subject to existing COA accounting rules and regulations.

SECTION 3. – In the event that the negotiation with the owner/s of the subject property fails, the City Mayor is hereby authorized to initiate and pursue expropriation proceedings to acquire and pay just compensation for this property. For this purpose, the City Mayor shall be represented by the Office of the City Legal Officer. Moreover, the City Mayor and the City Treasurer are hereby authorized to deposit in court fifteen (15%) percent of the fair market value of the property sought to be expropriated, or as maybe determined by the proper court, in accordance with law.

SECTION 4. – The City Mayor is authorized to engage the services of a duly licensed and qualified contractor for the design and construction of the housing building for the benefit of underprivileged Pasiguenos and those living in the danger zones and other government projects of the City Government of Pasig.

SECTION 5. – The amount to be used for the payment of the purchase price or just compensation shall be taken from the land capital outlay of the City Government of Pasig, subject to existing COA rules and regulations.

SECTION 6. – Should any article, section or regulation of this Ordinance be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of this Ordinance as a whole, or any portion thereof other than the article, section or regulation so declared to be unconstitutional or invalid.

SECTION 7. – All ordinances or portions of ordinances in conflict with this Ordinance, or inconsistent with the regulations of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

SECTION 8. – This Ordinance shall take effect immediately.
