WHEREAS, the Sangguniang Panlungsod enacted Ordinance 57, Series of 2020 last December 15, 2020 which shall govern the levy, assessment, and collection of taxes, fees, charges and other impositions within the territorial jurisdiction of Pasig City;

WHEREAS, Section 9, Pasig City Public Crematorium Charges –imposed fees for the services rendered by the Pasig City Public Crematorium, and thus, needs to be amended in order to include the additional services and corresponding fees with regards to the Cremation of Human Bones, Body parts and Transfer Permit of Bone and Cremation of Animals that will be offered to the residents and non-residents of Pasig City.

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF THE CITY OF PASIG IN REGULAR SESSION ASSEMBLED, THAT:

SECTION 1.AMENDMENT. – Section 9 of Ordinance No. 57, Series of 2021 is hereby amended and includes the following:




