WHEREAS, on 27 July 2017, the Pasig City Council enacted and subsequently approved by the City Mayor Ordinance No. 37, Series of 2017, entitled: "An Ordinance Organizing and Establishing the Pasig City Persons with Disability Affairs Office (PC-PDAO) and for other purposes";

WHEREAS, Section 5 thereof, however, only provides three (3) personnel complement to make the office operational as follows:

- a) Project Development Officer IV
- b) Administrative Aide V
- c) Administrative Aide III

WHEREAS, the Implementing Rules and Regulations (IRR) of Republic Act No. 10070, also known as "An Act Establishing an Institutional Mechanism to ensure the Implementation of Programs and Services for Persons with Disabilities in every Province, City and Municipality, amending Republic Act No. 7277, otherwise known as "The Magna Carta for Disabled Persons," as amended, and for other purposes", provides for the Organizational Structure of Persons with Disability Affairs Office under Rule VI thereof;

WHEREAS, there is a need to amend Ordinance No. 37, Series of 2017, to strengthen the personnel complement of the PC-PDAO and to align and harmonize with the provision of the abovementioned IRR of RA 10070;

WHEREAS, Section 458 (1) and (viii) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", grants upon the city council the power to approve ordinances and pass resolutions necessary for an efficient and effective city government, including the authority to determine the powers and

duties of officials and employees of the city and to determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF PASIG CITY IN REGULAR SESSION DULY ASSEMBLED:

SECTION 1. PERSONNEL COMPLEMENT AND QUALIFICATION STANDARDS. – Section 5 of Ordinance No. 37, Series of 2017 is hereby amended to read as follows:

A. PERSONNEL COMPLEMENT – The current personnel complement of the PC-PDAO is hereby strengthened to amend and include the following positions:

1	Disability Affairs Officer IV	22

2	Disability Affairs Officer I	11
2	Disability Affairs Assistant	8
1	Administrative Aide IV (Clerk II)	4

Priority shall be given to qualified PWDs to head and man the said office.

SECTION 2. APPROPRIATIONS. – The annual budget of the City shall provide funds for the salaries of the PC-PDAO Personnel, in PWD-oriented projects and in day-to-day operations, subject to budgetary limitations under the Local Government Code, Republic Act 7277 and other pertinent laws. The budget allocation of the PC-PDAO may not be decreased at any time, except by ordinance duly enacted by the City Council.

SECTION 3. SEPARABILITY CLAUSE. – If any provision of this Ordinance is declared unconstitutional or invalid, the provision not affected thereby shall continue to be in full force and effect.

SECTION 4. REPEALING CLAUSE. – All ordinances, rules and regulations or part thereof, in conflict with or inconsistent with any provision of the Ordinance are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY. – This Ordinance shall take effect immediately upon its approval.


