WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of welfare;

WHEREAS, Presidential Proclamation No. 929 was issued on 16 March 2020 declaring a state of calamity throughout the Philippines due to the coronavirus disease 2019 ("COVID-19") enjoining all government agencies and local government units to render full assistance and cooperation and mobilize necessary resources to undertake critical, urgent, and appropriate response measures in a timely manner to curtail and eliminate the threat of COVID-19;

NOW, THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD, IN SESSION DULY ASSEMBLED THAT:

SECTION 1. AMENDMENT TO SECTION 2. – Section 2 shall now be read as:

"It shall be the policy of the Local Government of Pasig to strictly require the mandatory wearing by all residents of face masks, except in open spaces and non-crowded outdoor areas with good ventilation, within the territorial jurisdiction of Pasig City."

SECTION 2. AMENDMENT TO SECTION 3. – Section 3 shall now be read as:

"It shall be unlawful for any person, whether natural or juridical, to refuse the mandatory wearing of face masks when going out of residences or as may be required by any establishment and on public places, except in open spaces and non-crowded outdoor areas with good ventilation, within the territorial jurisdiction of Pasig City."

SECTION 3. REPEALING CLAUSE. – All ordinances or portions of ordinances in conflict with this Ordinance, or inconsistent with the regulations of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

SECTION 5. EFFECTIVITY. – This Ordinance shall take effect immediately.






