AN ORDINANCE AMENDING ORDINANCE NO. 19 SERIES OF 2021 TO READ AS: AN ORDINANCE AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO TO ENTER INTO NEGOTIATION WITH ZENAIDA F. PUZON, FOR THE ACQUISITION OF A PARCEL OF LAND, WITH AN AREA OF TWO HUNDRED TWENTY-SIX (226) SQUARE METERS MORE OR LESS, DESCRIBED UNDER TRANSFER CERTIFICATE OF TITLE NO. 64058 LOCATED IN BARANGAY PINAGBUHATAN, PASIG CITY, TO BE USED FOR HOUSING PROGRAM OF THE CITY GOVERNMENT OF PASIG, AND TO EXPROPRIATE THE SAME IF NEGOTIATIONS FAIL.

WHEREAS, Section 16 of the Republic Act No. 7160 otherwise known as the Local Government Code ("code") provides that, every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

WHEREAS, Section 17 (b) (2) (viii) and Section 17 (b) (13) (vii) in relation to Section 17 (b) (4) of the Republic Act No. 7160 of the same code provides that, the City has the duties and responsibility of constructing infrastructure facilities intended primarily to service the needs of its residents including the construction of roads, multi-purpose buildings, housing facilities, among others;

WHEREAS, Section 19 of the same code further provides that, a local government unit may, through its chief executive and acting pursuant to an ordinance, exercise the power of eminent domain for public use, or purpose, or welfare for the benefit of the poor and the landless, upon payment of just compensation;

WHEREAS, there is an urgent need for the City Government of Pasig to address the problems brought about by informal settlers and those residing in the danger zones;

WHEREAS, the property of Zenaida F. Puzon, with an area of two hundred twenty-six (226) square meters more or less, described under Transfer Certificate of Title No. PT-64058, located in Barangay Pinagbuhatan, Pasig City, was identified by the Pasig Urban Settlement Office as suitable for housing program and other government projects of the City Government of Pasig considering it is already inhabited by informal settler families and is suitable for on site development.

NOW THEREFORE, be it ordained as it is hereby ordained by the Sangguniang Panglungsod of Pasig in a session duly assembled the following:

SECTION 1. – The Honorable City Mayor Victor Ma. Regis N. Sotto is hereby authorized to negotiate and/or initiate expropriation proceedings for the acquisition of the subject property registered under Transfer Certificate of Title No. 64058, with an area of two hundred twenty-six (226) square meters more or less, located in Barangay Pinagbuhatan, Pasig City, to be used for housing program of the City Government of Pasig, and the payment of just compensation thereof to the registered owner.

For this purpose, the City Mayor may delegate and/or authorize the Office of the City Legal Officer – Pasig City to represent him or Office of the City Mayor to make the written offers and negotiate with the affected owners.

SECTION 2. – The City Mayor is further authorized in case of a negotiated sale to pay the purchase price of the subject property, as agreed upon by the parties, and subject to existing COA accounting rules and regulations.

SECTION 3. – In the event that the negotiation with the owner/s of the subject property fails, the City Mayor is hereby authorized to initiate and pursue expropriation proceedings to acquire and pay just compensation for this property. The City Mayor and the City Treasurer are hereby authorized to deposit in court fifteen (15%) percent of the fair market value of the property sought to be expropriated, to be determined by the proper court, in accordance with law.

SECTION 4. – The City Mayor is authorized to engage the services of a duly licensed and qualified contractor for the design and construction of the housing building for the benefit of underprivileged Pasiguenos and those living in the danger zones and other government projects of the City Government of Pasig.

SECTION 5. – The amount to be used for the payment of the purchase price or just compensation shall be taken from the land capital outlay of the City Government of Pasig, subject to existing COA rules and regulations.

SECTION 6. –Should any article, section or regulation of this Ordinance be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of this Ordinance as a whole, or any portion thereof other than the article, section or regulation so declared to be unconstitutional or invalid.

SECTION 7. – All ordinances or portions of ordinances in conflict with this Ordinance, or inconsistent with the regulations of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

SECTION 8. – This Ordinance shall take effect immediately.
