AN ORDINANCE PROVIDING GUIDELINES FOR THE GRANT OF ONE-TIME RICE ALLOWANCE IN THE MAXIMUM AMOUNT OF TWO THOUSAND FIVE HUNDRED PESOS (PHP 2,500.00) EACH TO CONTRACT OF SERVICE AND JOB ORDER WORKERS OF THE CITY GOVERNMENT OF PASIG, APPROPRIATING FUNDS THEREOF, AND FOR OTHER PURPOSES.

WHEREAS, on 16 December 2022 President Ferdinand R. Marcos Jr. signed Administrative Order No. 2, Series of 2022 (Administrative Order No. 2), which authorize the one-time grant of rice allowance to all government employees and workers for Fiscal Year 2022;

WHEREAS, Administrative Order No. 2 was issued as recognition to all employees and workers in the government for their collective and unceasing participation in and invaluable contribution to the efficient and responsive delivery of services to the public, especially in the midst of COVID-19 pandemic;

WHEREAS, the grant of assistance in the form of rice to workers and employees in government will help mitigate the effects of the current socio-economic challenges in their respective households;

WHEREAS, the benefit to be gained from the grant of the said assistance will be two-fold as it will not only benefit those working in the government but will also result in better economic opportunities for those in the agricultural sector;

WHEREAS, Section 6 of Administrative Order No. 2 allowed the grant of one-time rice allowance to Contract of Service (COS) and Job Order (JO) workers in the Local Government Units depending on the latter's financial capabilities, subject to the pertinent provisions under RA No. 7160 or the Local Government Code of 1991, chargeable against their respective FY 2022 local government funds;

WHEREAS, to mitigate the burden caused by the increasing prices of basic commodities, the City Government of Pasig deems it meritorious to grant a one-time rice allowance to all of its COS and JO workers;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod that:

SECTION 1. GRANT OF RICE ALLOWANCE. – All COS and JO workers of the City Government of Pasig is hereby granted a one-time rice allowance in the amount of Two Thousand Five Hundred pesos (Php 2,500.00).

SECTION 2. CONDITIONS ON THE GRANT OF RICE ASSISTANCE. –

The beneficiaries of the one-time rice allowance stated herein must still working and/or engaged by the city government as of 30 November 2022.

SECTION 3. BUDGETARY REQUIREMENT. -

The budgetary requirement to implement this Ordinance shall be chargeable against any available funds in the MOOE of the City, subject to existing rules and regulations of the Commission on Audit.

SECTION 4. REPEALING CLAUSE. –

All ordinances or portions of ordinances in conflict with this Ordinance, or inconsistent with the regulations of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

SECTION 5. SEPARABILITY CLAUSE. –

If for any reason, any section or provision of this Ordinance is held to be unconstitutional or invalid by competent authority, such judgment or action shall not affect or impair the other sections or provisions hereof.

SECTION 6. EFFECTIVITY. –

This Ordinance shall take effect immediately.
