**WHEREAS**, the Local Government Code provides that the territorial and political subdivisions of the State shall enjoy genuine and meaningful local autonomy to enable them to attain their fullest development as self-reliant communities and make them more effective partners in the attainment of national goals. Toward this end, the State shall provide for a more responsive and accountable local government structure instituted through a system of decentralization whereby local government units shall be given more powers, authority, responsibilities, and resources. The process of decentralization shall proceed from the national government to the local government units.

**NOW, THEREFORE**, on motion duly seconded, the Sangguniang Panlungsod of Pasig, in session assembled do hereby ordained that:

**Section 1.** The newly constructed bridge connecting Lopez Jaena Street in Barangay Sumilang and F. Flores Street in Barangay Buting, Pasig City (Sumilang-Buting Bridge) is hereby named as **Kaunlaran Bridge**.

**Section 2.** Separability Clause – If for any reasons, any part or provision of this Ordinance is held to be unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to be in full force and effect.

**Section 3.** Repealing Clause – Any ordinance, order, memorandum, rule and regulation which is consistent with the provisions of this Ordinance is hereby modified or repealed accordingly.

**Section 4.** Effectivity – This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation within the City.





- Francisco V. Coching
  - national artist in the field of visual arts
  - Aside from being the Dean of Filipino illustrators, he is also recognized as the Dean of Filipino Comics.
  - born in buting in January 29, 1919
- Gregorio Coching
  - a well known "kwentista at nobelista" before WWII
  - the father of Francisco Coching
- Francisco Tanangco
  - a sculptor, writer and poet from Buting
- Rufina Esperancilla
  - 1st champion in the 1960 Tawag ng Tanghalan national contest
- Amado T. Yson
  - director and scriptwriter of the Buting Cenaculo
- Genaro Q. Sambeli
  - poet, writer and radio announcer

#### Sumilang:

- Buddy Encarnado
  - a well known figure in the PBA
- Ernie Cloma
  - one of the founders of PETA
