AN ORDINANCE GRANTING STUDY LEAVE AND SCHOLARSHIP TO PERMANENT FULL TIME FACULTY OF THE PAMANTASAN NG LUNGSOD PASIG (PLP) AND FOR OTHER PURPOSES.

WHEREAS, The Commission on Higher Education (CHED) in its CMO No. 40, s. 2008 requires that all faculty members of all higher educational institutions shall be holders of at least a master's degree relevant to their field or discipline and that the current roster of full-time faculty members of the PLP shows that the school is fully compliant with this,

WHEREAS, to further improve the profile of its faculty, the PLP encourages its faculty to pursue higher or doctoral degrees in its objective to improve the quality of the faculty which then results to better instruction and therefore better quality of education, thus the PLP subscribes to the concept of faculty development and commits to provide the privilege to its faculty by providing access to special avenues and opportunities such as granting study leaves, scholarships, incentives and awards

WHEREAS, faculty development is both a responsibility and privilege of the faculty members by virtue of their profession and their unique position in the local academic sphere as part of the roster of a university roster of faculty.

WHEREAS, The PLP Board of Regents reviewed the previous ordinances related to study leave and scholarship grants and found them already inappropriate and inadequate to the present situation of the school, thus endorsing amendments that are now contained in this proposed ordinance.

WHEREAS, the Pasig City Council is in agreement with faculty development and in improving the instruction at the PLP and finds this proposal as appropriate and developmental.

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG DULY ASSEMBLED THAT:

SECTION 1. Short title. 2023 Ordinance on Study leave and Scholarship Grant to Permanent Full Time Faculty Pursuing their Doctoral Degrees.

SECTION 2. Eligibility: Applicants for the study leave and scholarship grant must be:

1. Permanent full-time members who are master degree holders.
2. Have taught on full time basis for at least two years.
3. Must have admission and/or are enrolled in a duly certified university's (DCU) doctoral degree program.

4. Must have a certification from the Dean of applicant's college that her/his pursuit of the study will not affect adversely the academic load of the college.
5. Must have a certification from the university (DCU) that the applicant will be able to complete her/his academic program within a period of one year.
6. The study leave is subject to a two-year return service.

SECTION 3. The Scholarship grant.

1. Each grantee of the study leave can apply for a scholarship to be granted on the last semester of her/his study.
2. The scholarship grant is in the amount of Fifty Thousand Pesos (P50,000.00) to be given during the last semester of the study leave and another Fifty Thousand Pesos (P50,000.00) upon completion of the return service.

SECTION 4. Implementing Authority. The Head of the Academic Department of the PLP shall be in charge of the implementation of this Ordinance within the Pamantasan and shall be reporting to the Board of Regents headed by the City Mayor at the beginning of every Academic Year.

SECTION 5. Appropriation. The budgetary requirement to implement this Ordinance shall be chargeable against any available funds in the City Treasury subject to existing COA rules and regulations.

SECTION 6. Repealing Clause. This Ordinance repeals Ordinance No. 29, Series of 2013, Related ordinances that prove inconsistent with the provisions of this policy are hereby revised, modified or rescinded accordingly. Furthermore, this Ordinance should not serve to limit or modify existing and relevant laws, rules and regulations.

SECTION 7. Separability Clause. If any part or provision of this Ordinance shall be held invalid or illegal by a competent authority, the remaining portions which are not affected thereby shall continue to be in full force and effect.

SECTION 8. Effectivity. This ordinance shall be applicable to those who applied for study leave and scholarship starting the academic year 2022-23 and will be in effect until its repeal.






