AN ORDINANCE GRANTING EXEMPTION FROM PAYMENT OF ALL CONSTRUCTION WORK PERMIT FEES RELATING TO THE CONSTRUCTION OF METRO MANILA SUBWAY PROJECT, AND FOR OTHER PURPOSES.

WHEREAS, the Metro Manila Subway Project (MMSP) is the first subway project in Metro Manila that will connect Meycauayan, Bulacan and Dasmarinas, Cavite through the National Capital Region (NCR) which is spearheaded by the national government particularly the Department of Transportation;

WHEREAS, there will be thirteen (13) underground stations traversing six (6) cities in NCR, and two (2) of the said stations namely the Ortigas North and Ortigas South are located in Pasig City;

WHEREAS, the MMSP will cause pre-construction, construction and operational impacts to the city such as clearing and removal of trees, movement and operation of construction machinery, construction and demolition works, and excavation;

WHEREAS, the City Government of Pasig through Ordinance No. 51, Series of 2017 or the 2017 Revised Pasig Revenue Code, charges permit fees for various purposes, and the Department of Transportation sought for exemption from payment of permit fees for excavation permit, demolition permit, traffic clearance and locational clearance, in order to proceed with its pre-construction work;

WHEREAS, to support the MMSP and assist in the numerous permit applications in relation thereto, the City Government of Pasig deems it meritorious to waive any work permit fees relating to the construction of the MMSP;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG CITY, METRO MANILA, BY VIRTUE OF THE POWER VESTED IN IT BY LAW, IN SESSION DULY ASSEMBLED, THAT:

Section 1. General Provision – The exemption from payment of demolition permit, excavation permit, traffic clearance, locational clearance and all construction work permit fees relative to the construction of the Metro Manila Subway Project is hereby granted, except on the payment of permit to cut trees. Provided, that the application of permit is for the sole purpose of the construction of the Metro Manila Subway Project.

Section 2. Period – The exemption from payment of permit fees mentioned in Section 1 of this Ordinance shall be imposed only during the period of the said construction which affects the territorial jurisdiction of Pasig City.

AN ORDINANCE GRANTING EXEMPTION FROM PAYMENT OF ALL CONSTRUCTION WORK PERMIT FEES RELATING TO THE CONSTRUCTION OF METRO MANILA SUBWAY PROJECT, AND FOR OTHER PURPOSES.

Section 3. Separability Clause – If for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, the remainder of the Regulation shall not be affected by such declaration and shall remain in force and effect.

Section 4. Repealing Clause – All Ordinances and other issuances inconsistent with this Ordinance are hereby superseded, amended or modified accordingly.

Section 5. Effectivity Clause – This Ordinance shall take effect fifteen (15) days after its publication in two (2) newspapers of general circulation and after posting of copies in conspicuous locations within Pasig City for a period of fifteen (15) days.
