AN ORDINANCE APPROPRIATING THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (PHP 500,000.00) TO SERVE AS CONTINGENCY FUND FOR THE LOCAL GOVERNMENT'S SHARE IN THE SUBSIDY OF CINEMA ADMISSION PRICES OF DULY REGISTERED AND VALIDATED SENIOR CITIZENS IN PASIG CITY AND FOR OTHER PURPOSES.

WHEREAS, Article XV Section 4 of the 1987 Philippine Constitution provides that the family has the duty to care for its elderly members, but the State may also do so through programs of social security for them;

WHEREAS, the 1987 Philippine Constitution recognizes the importance of partnering with the private sector in improving the welfare of senior citizens;

WHEREAS, in recognition of the rights and contributions of senior citizens to society, the City Government of Pasig has decided to extend certain benefits to them such as free admission to movie houses or cinemas;

WHEREAS, the Sangguniang Panlungsod has authorized the Honorable City Mayor Victor Ma. Regis N. Sotto to negotiate the terms of subsidizing admission tickets and to enter into a Memorandum of Agreement with commercial establishments operating movie houses or cinemas within the City of Pasig;

WHEREAS, there is a need to assure the private sector that the City Government of Pasig is committed to meet its share in subsidizing the admission of senior citizens to movie houses or cinemas even if the collectible amusement tax is insufficient to offset such subsidy;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod ng Pasig, in session duly assembled that:

SECTION 1. APPROPRIATION. – The amount of Five Hundred Thousand Pesos (Php 500,000.00) is hereby appropriated as contingency fund for the City Government's share in the cinema admission prices of senior citizens, which is to be charged to any available funds in the City Treasury, subject to existing COA rules and regulations. However, this fund shall be used only if the share of the City Government of Pasig in the subsidy of cinema admission prices exceeds the collectible amount of amusement tax for the same period.

SECTION 2. TERM. – The above amount shall be appropriated every year from 2023 onwards and may be adjusted by the Sangguniang Panlungsod as may be required by the circumstances.

SECTION 3. REPEALING CLAUSE. – Any ordinance, resolution or executive order that is inconsistent with this ordinance or any provision hereof is hereby repealed or amended.




