**AN ORDINANCE ESTABLISHING AND CREATING PRIMARY CARE FACILITIES IN PASIG CITY.**

**WHEREAS**, health is one of the priority programs of the Honorable Mayor Victor Ma. Regis N. Sotto;

**WHEREAS**, Article II, Section 15 of the 1987 Philippine Constitution provides that "the State shall protect and promote the right to health of the people and instill health consciousness among them";

**WHEREAS**, Article XIII, Section 11 also states that "the State shall adopt an integrated and comprehensive approach to health development in which shall endeavor to make essential goods, health and other social services available to all people at affordable cost";

**WHEREAS**, Section 16 of RA 7160, also known as the Local Government Code of 1991, provides that "Every local government unit shall exercise powers expressly granted, those necessarily implied therefrom x x x and those which are essential to the promotion of general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, x xx maintain peace and order, and preserve the comfort and convenience of their inhabitants";

**WHEREAS**, Universal Health Care or Kalusugan Pangkalahatan has been adopted as the Department of Health's implementation framework for health sector reforms by seeking to improve, streamline and scale up reform strategies in the Health Sector Reform Agenda;

**WHEREAS**, Kalusugan Pangkalahatan aims to attain the goals of better health outcomes, more responsive health systems and equitable health care financing especially the poor by pursuing the three (3) strategic thrust of financial risk protection, improved access to quality health care facilities and attainment of health-related sustainable development goals;

**NOW, THEREFORE,** be it **ORDAINED,** as it is hereby **ORDAINED,** by the Sangguniang Panlungsod in its regular session assembled that:

**SECTION 1.** It is the policy of the City of Pasig to:

- a. Safeguard the rights of its constituents to have equitable access public health facilities such as primary care facilities;
- b. Protect and save lives of its constituents;
- c. Provide free medical services that are responsive to the needs of all Pasigueños; and
- d. Promote good health and healthy lifestyle among all Pasigueños.

**SECTION 5.** The primary care facilities shall mandatorily comply with the licensing and accreditation standards of the Department of Health, Philhealth, and other related or affiliated government institutions.

**SECTION 6. APPROPRIATIONS.** - The funds necessary for the completion and operations of the primary care facilities, acquisition of vehicles, equipment, supplies, and staffing pattern shall be included in the Executive Budget and shall be adjusted every year thereafter;

**SECTION 7. SEPARABILITY CLAUSE.** - If for any reason, any section or provision of this Ordinance is held to be unconstitutional or invalid by competent authority, such judgment or action shall not affect or impair the other sections or provisions hereof.

**SECTION 8. REPEALING CLAUSE.** - All ordinances or portions of ordinances in conflict with this Ordinance, or inconsistent with the regulations of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

**SECTION 9. EFFECTIVITY.** - This Ordinance shall take effect immediately upon its approval.


