AN ORDINANCE RENAMING THE PASIG CITY MEGA MARKET TO THE MUTYA NG PASIG MEGA MARKET.

WHEREAS, Section 13(b) of Republic Act No. 7160 or the Local Government Code of 1991 provides that, the Sangguniang Panlungsod may change the name of a public place or building owned by the City Government within its territorial jurisdiction;

WHEREAS, the Pasig City Mega Market located at Caruncho Avenue, Pasig City, was established in 1974;

WHEREAS, as the center of commerce of the then Rizal Province, the Market was named and known as the Mutya ng Pasig Public Market;

WHEREAS, in line with the celebration of the 450th Araw ng Pasig, the City Government of Pasig deems it meritorious to revive the original name of the Market in recognition of its vital role in the history and development of the City;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF PASIG CITY IN REGULAR SESSION ASSEMBLED, THAT:

SECTION 1. The Pasig City Mega Market is hereby officially named as the "Mutya ng Pasig Mega Market".

SECTION 2. All other ordinances, resolutions, orders, rules and regulations or parts thereof which are inconsistent with this Ordinance, are hereby repealed.

Section 3. This Ordinance shall take effect immediately.






