**AN ORDINANCE AMENDING APPENDICES I & II, AND ADDING APPENDIX IV-B ON ARTICLE XXVIII OF ORDINANCE NO. 23, SERIES OF 2016 (TRAFFIC AND PARKING MANAGEMENT CODE), DECLARING CERTAIN STREETS OF BARANGAY MANGGAHAN, PASIG CITY, AS ONE WAY STREETS, NO LEFT TURN STREET AND NO PARKING ON ONE SIDE STREETS, AND FOR OTHER PURPOSES.**

**WHEREAS**, Section 16 of Republic Act No. 7160, also known as the Local Government Code of 1991, vested authority to the local government unit to exercise the powers expressly granted, those necessarily implied there from as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. The City Government is mandated to promote for the health, safety, comfort and convenience of all its inhabitants;

**WHEREAS**, pursuant to Sections 458 (a)(5)(v) and (vii) of the Local Government Code, the Sangguniang Panlungsod is empowered to approve ordinances to regulate the use of streets, avenues, alleys, sidewalk, bridges, parks and other public places, and to regulate traffic on all streets and bridges to ensure the efficient and effective delivery of the basic services and facilities as provided for under Section 17 of the same Code;

**WHEREAS**, Ordinance No. 23, Series of 2016, otherwise known as the Revised 2016 Traffic and Parking Management Code of Pasig City ("Revised Traffic Code") provides for the traffic and parking rules and regulations for all transport vehicles operating within and traversing the territorial jurisdiction of the City of Pasig;

**WHEREAS**, Section XXVIII, Appendix I of the Revised Traffic Code provides for the list of one-way streets in Pasig City, Appendix II for no left turn streets, and Appendix IV for no parking at all times streets;

**WHEREAS**, the Traffic and Parking Management Office continuously identifies traffic bottleneck points and propose updated traffic schemes within the City of Pasig pursuant to its mandate under the Revised Traffic Code to regulate traffic flow and in compliance with road clearing guidelines set by the national government for public safety and health;

**WHEREAS**, after conducting public consultation, the TPMO recommends to amend Article XXVIII, Appendices I, II, and IV of the Revised Traffic Code, to declare certain streets, roads, and avenues within the city as one-way streets, no left turn streets, no parking at all times streets/tow away zone/tire clamping zone, and no parking on one side streets;

**SECTION 5 – REPEALING CLAUSE** – All laws, orders, issuances, rules and regulations or parts thereof inconsistent with this Ordinance are hereby repealed or modified accordingly.

**SECTION 6. EFFECTIVITY** – This Ordinance shall take effect fifteen (15) days following the publication in a newspaper of general circulation.
