**WHEREAS**, the reversion is pursuant to the adoption of the City Development Council Resolution No. 4, Series of 2023;

**NOW, THEREFORE**, be it ordain, as it is hereby ordained by the Sangguniang Panlungsod, in session duly assembled the following:

**SECTION 1. REVERSION OF FUND.** - There is hereby reverted the sum of Seventy-Two Million Two Hundred Seventy-Eight Thousand Pesos (Php 72,278,000.00) representing the savings of the City of Pasig.

**SECTION 2. EFFECTIVITY.** - This Ordinance shall take effect immediately.
