AN ORDINANCE AUTHORIZING THE REVERSION OF CURRENT AND CONTINUING APPROPRIATION OF THE GENERAL FUND IN THE AMOUNT OF SIX HUNDRED EIGHTY-FOUR MILLION EIGHT HUNDRED FIFTY-EIGHT THOUSAND EIGHT HUNDRED FIFTY-NINE AND 22/100 PESOS (PHP 684,858,859.22), SUBJECT TO APPLICABLE LAWS, RULES AND REGULATIONS, AND FOR OTHER PURPOSES.

**WHEREAS**, the City Government of Pasig has continuing appropriations in the amount of Six Hundred Thirty-One Million Pesos (Php 631,000,000.00) which remains free of any encumbrance and still available after unavoidable discontinuance of the activity or purpose for which the appropriation was originally appropriated;

**WHEREAS**, the City Government of Pasig has current appropriations in the amount of Fifty-Three Million Eight Hundred Fifty-Eight Thousand Five Hundred Eighty-Nine and 22/100 Pesos (Php 53,858,589.22) which remains free of any encumbrance and still available after unavoidable discontinuance of the activity or purpose for which the appropriation was originally appropriated;

**WHEREAS**, there is a need to revert the appropriation of Six Hundred Eighty-Four Million Eight Hundred Fifty-Eight Thousand Five Hundred Eighty-Nine and 22/100 Pesos (Php 684,858,589.22) to be reprogrammed for the Second Supplemental Investment Plan of the City Government of Pasig;

**WHEREAS**, the Officer-in-Charge (OIC) of the City Budget Office, OIC of the City Treasury Office and OIC of the City Accounting Office all certified the existence and availability of Six Hundred Eighty-Four Million Eight Hundred Fifty-Eight Thousand Five Hundred Eighty-Nine and 22/100 Pesos (Php 684,858,589.22) as available source for Supplemental Budget No. 02, Series of 2023;

**NOW, THEREFORE**, be it ordain, as it is hereby ordained, by the Sangguniang Panlungsod in a session duly assembled the following:

**SECTION 1. REVERSION OF FUND.** - There is hereby reverted the sum of Six Hundred Eighty-Four Million Eight Hundred Fifty-Eight Thousand Five Hundred Eighty-Nine and 22/100 Pesos (Php 684,858,589.22) representing the savings of City of Pasig.

**SECTION 2. - EFFECTIVITY.** - This Ordinance shall take effect immediately.






