AN ORDINANCE AMENDING ORDINANCE NO. 59, SERIES OF 2023, ENTITLED "AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 2 OF THE GENERAL FUND OF THE CITY GOVERNMENT OF PASIG, METRO MANILA INVOLVING A TOTAL APPROPRIATION OF NINE HUNDRED SEVENTY-NINE MILLION EIGHT HUNDRED SEVENTY-FIVE THOUSAND FOUR HUNDRED EIGHTY-FIVE PESOS AND 47/100 (PHP 979,875,485.47) TO FINANCE ADDITIONAL EXPENSES, PROJECTS AND PROGRAMS OF CITY, AND FOR OTHER PURPOSES".

WHEREAS, the Sangguniang Panlungsod enacted Ordinance No. 59, Series of 2023 entitled: "An Ordinance authorizing Supplemental Budget No. 2 of the General Fund of the City Government of Pasig, Metro Manila involving a total appropriation of Nine Hundred Seventy-Nine Million Eight Hundred Seventy-Five Thousand Four Hundred Eighty-Five Pesos and 47/100 (Php 979,875,485.47) to finance additional expenses, projects and programs of the City, and for other purposes." ("*Supplemental Budget Ordinance*");

WHEREAS, the said Supplemental Budget Ordinance contains the purchase of various supplies, equipment, various programs and infrastructure projects for the continuous operation of the City Government of Pasig;

WHEREAS, Section 1 of the Supplemental Budget Ordinance appropriated funds for the partial dismantling and relocation of stepdown modular facility from PLP to YDC for the City Engineering Office ("*Project*") under the Capital Outlay, thus:

Should any article, section or regulation of this Ordinance be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of this Ordinance as a whole, or any portion thereof other than the article, section or regulation so declared to be unconstitutional or invalid.

SECTION 4. All ordinances or portions of ordinances in conflict with this Ordinance, or inconsistent with the regulations of this Ordinance, are hereby amended or repealed to the extent necessary to give this Ordinance full force and effect.

SECTION 5. This Ordinance shall take effect immediately.
