AN ORDINANCE LOWERING THE PRESUMPTIVE INCOME LEVELS OF THE MUTYA NG PASIG MEGA MARKET VENDORS FOR THE YEAR 2023, AND FOR OTHER PURPOSES.

WHEREAS, Sections 16 and 458 of Republic Act. No. 7160, also known as the Local Government Code of 1991, states that within their respective territorial jurisdictions, local government units shall ensure and support, among other things, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 61 of Ordinance No. 51, Series of 2017, otherwise known as the 2017 Pasig City Revenue Code, imposes a presumptive income level, based on the stratified schedule prepared by the City Treasurer to approximate the gross receipt of each and all business classifications in the event that the taxpayer fails to provide valid supporting financial documents in his declaration of gross sales/receipts/revenue;

WHEREAS, the Sangguniang Panlungsod previously enacted Ordinances to alleviate the financial burdens of Pasig Mega Market vendors, and the City Government deems it meritorious to continue the lowering of the presumptive income level for the Mutya ng Pasig Mega Market vendors for the year 2023;

NOW, THEREFORE, be it **ORDAINED** as it is **ORDAINED** by the Sangguniang Panlungsod ng Pasig, in session duly assembled, the following:

SECTION 1. TEMPORARY PRESUMPTIVE INCOME LEVEL OF MUTYA NG PASIG MEGA MARKET VENDORS – For the year 2023, the presumptive income of registered businesses in the Mutya ng Pasig Mega Market shall be temporarily lowered to the following rates:

Candies and Bread	75%
Food Court	75%
Chicken	75%
Charcoal and Sticks	25%
Dried Fish	75%
Egg	75%
Fruit – Retail	75%
Fruit – Wholesale	75%

SECTION 2. DURATION. – The effectivity of the same shall be for one (1) year beginning January 1, 2024 until December 31, 2024.

SECTION 3. SEPARABILITY CLAUSE – Should any article, section or regulation of this Ordinance be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of the Ordinance as a whole, or any portion thereof other than the article, section or regulation so declared to be unconstitutional or invalid.

SECTION 4. REPEALING CLAUSE – All ordinances or portions of ordinances in conflict with this Ordinance, or inconsistent with the regulations of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

SECTION 5. EFFECTIVITY CLAUSE – This Ordinance shall take effect on January 1, 2024.
