AN ORDINANCE APPROVING THE RE-PROGRAMMING OF ONE BILLION FIVE HUNDRED EIGHTY-FIVE MILLION NINE HUNDRED THIRTY-FIVE THOUSAND PESOS (PHP 1,585,935,000.00) ALLOCATED FOR BUILDINGS (HOUSING PROJECTS @ KALAWAAN - MRB FIRST BUILDINGS) TO BUILDING (HOUSING PROJECTS) OF SUPPLEMENTAL BUDGET NO. 1, SERIES OF 2021

WHEREAS, on 14 May 2021, the Sangguniang Panlungsod of Pasig enacted Supplemental Budget No. 1, Series of 2021, in the amount of Three Billion Seven Hundred Eighty-Six Million Two Hundred Seventy-Six Thousand and Six Hundred Fifty-Seven Pesos (Php 3,786,276,657.00) through Ordinance No. 16, Series of 2021;

WHEREAS, under Supplemental Budget No. 1, Series of 2021, an amount of One Billion Five Hundred Eighty Five Million and Nine Hundred Thirty Five Thousand Pesos (Php 1,585,935,000.00) was allocated for the project - Buildings (Housing Projects @ Kalawaan - MRB first 3 Buildings);

WHEREAS, the Local Finance Committee of the City Government of Pasig recommended the re-programming of the amount allocated for Buildings (Housing Projects @ Kalawaan - MRB first 3 Buildings) to Building (Housing Projects) in order to properly utilize the funds allocated to the said project;

WHEREAS, pursuant to the provisions of the Local Government Code of the Philippines (Republic Act No. 7160), particularly Sections 285 to 287, which authorize local government units to allocate and reprogram funds for different purposes as deemed necessary;

NOW, THEREFORE, BE IT ORDAINED, by the Sangguniang Panlungsod of Pasig, that:

SECTION 1. The re-programming of the amount of One Billion Five Hundred Eighty-Five Million and Nine Hundred Thirty-Five Thousand Pesos (Php 1,585,935,000.00) originally allocated for Buildings (Housing Projects @ Kalawaan - MRB First 3 Buildings) to Building (Housing Projects) in the Supplemental Budget No. 1, Series of 2021 is hereby approved.

SECTION 2. This re-programming shall ensure the effective and efficient utilization of the allocated funds towards the broader category of Housing Projects within the city.



SECTION 3. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed or modified accordingly.


SECTION 4. This ordinance shall take effect immediately upon its approval and after meeting all necessary legal requirements for its publication and posting.






